## President's Message

In **January**, in preparation for our Annual Meeting in April, **Caroline Emmons-Schramm**, former state League president, and LWVUS National Coaching Team Ruth Shur Fellow will take us through the program planning process. First elected to the Florida House in 1968 and to the Florida Senate in 1974, he served six years in each legislative body. From 1983-89, he served three terms in the U.S. House of Representatives. He served eight years as lieutenant governor with Gov. Lawton Chiles, and after Gov. Chiles' sudden death, served as Florida's 42<sup>nd</sup> governor until Jeb Bush was sworn in.

In **March**, we will be meeting as the Leesburg Public Library, and our guest speaker will be **Dr. Charles Mojock**, President of Lake-Sumter Community College which is currently serving over 7500 students on three campuses in Lake and Sumter counties.

At our **December** board meeting, we voted to change the meeting date of our monthly board meetings from the second Monday of the month to immediately following our monthly general meetings. This will begin with our **January 2012** board meeting. Hopefully, by making this change, it will encourage more participation on our board by our members.

Lastly, I would like to officially welcome back the **LWV of Marion County MAL Unit** to our area after a long absence. The convener is **Allie Gore**. Allie and another Marion MAL member attended our Holiday Luncheon, and we look forward to working with them as the election season gets underway. ## LWVUS Education Consensus

Many thanks to **Bernice Cozewith, Carolyn Johnson** and the members of the **Education Committee** for their hard work these last several months in gathering and disseminating all the information that was presented to us at our two consensus meetings.

The results of our meetings have been sent to LWVUS. After receiving the material it is up to the national League Board to determine whether or not consensus has been reached by Leagues across the country. We should find out more in April so stay tuned!

## Voter Service & Education

The redistricting maps will be taken up during the first weeks of January when the 2012 Legislative Session begins. Once these maps are approved and voted on, we will have a better idea of our new voting districts on the national, state and local levels.

The **Republican Presidential Primary** is **January 31** (book closing, January 3, 2012); the **Florida Primary is August 14** (book closing, July 16) and the **General Election** is **November 6, 2012** (book closing, October 9).



Because local Leagues across the state are under a self-imposed moratorium with regard to registering voters, if you or someone you know wants to check on their registration status, they can do so now because the League of Women Voters of Florida has made it easy to be ready: with one scan of your smartphone, our Be Ready Tag can connect you to the Division of Elections to check your voter status. If you need to make a change, you will then be connected to your local Supervisor of Elections via phone, email or website link to register, change party affiliation, address, name, signature or renew your absentee ballot request.

Don't know what a tag is: Find out by [clicking here](#) and then go to your smart phone and get a free download for the tag mechanism at <http://gettag.mobi>. Once that's on your phone you can scan the tag from the image above.

Once again, as our League did two years ago, we will be putting together presentations on the proposed amendments on the 2012 ballot as well as hosting a candidates' forum. Help will be needed to research the pros and cons of the amendments as well as with speaking engagements and candidate forums. While some people feel the League is nonpartisan, I think I can safely say that after our experiences two years ago, our League received nothing but positive feedback about our presentations. So, whether people realize it or not, there is a place for nonpartisanship and civility in the political process. Join the Voter Service & Education Committee and help educate the citizens of the tri-county area about the upcoming ballot issues. Make your participation one of your New Year's resolutions!

## From LWVUS

### **Elections: Voters Depend on the Attorney General for Real Action**

Earlier this week, U.S. Attorney General Holder traveled to the Lyndon Baines Johnson Library & Museum in Texas to address the growing momentum behind anti-voter laws. In its [statement](#), the League applauded Holder's speech, but expressed disappointment in the Department of Justice's record on voting rights enforcement. The League called on the DOJ to act more forcefully and without delay to ensure fair elections in 2012. ### **Elections: LWV Fights Voter Suppression Laws – Multiple Fronts in Multiple Ways**

As voter suppression laws sweep the nation, the League is fighting back in a variety of ways. The [LWV of Kansas](#) is working in coalition to help educate and register voters before new, stricter laws go into effect. The [LWV of South Carolina](#) steps up the pressure urging the US Department of Justice to deny pre-clearance of the state's voter ID law. The [LWV of Ohio](#), working with other organizations, succeeded in getting a measure on the ballot to overturn a newly enacted law that would significantly decrease the number of early voting hours in Ohio. The LWV of Florida has taken its message to national TV! [LWVFL President Deirdre McNabb](#) eloquently rebuffed a state legislator, who supported the state's new restrictions on citizen registration drives.
