President Notes Gail Formanack

I am writing this message the day following the inauguration, and I'm sure many Leaguers join me in a big sigh of relief that the peaceful transition of power was able to take place despite the attempt to interfere in the electoral process at the Capitol just two weeks before. LWVUS issued a strong statement condemning the actions of January 6th and calling for the removal of Donald Trump for his role in inciting these acts of domestic terrorism.

The League's job remains the same as it has for 100 years: to empower voters and defend the election process at the core of our democracy. Sadly, the many unsubstantiated claims regarding fraudulent election practices have been believed by many voters. We have our work cut out for us as the League takes up an education effort to replace these myths with the facts about the many safeguards in place protecting our elections. Members of our local League's speakers' bureau have stepped up to the task of creating such a presentation which will be reviewed by the state League's leadership and made available to all Florida Leagues as we add this to our toolbox for our voter education efforts. We also have much to do in terms of helping people identify unbiased information sources. I personally find it sad when marketing materials for publications such as *The Epoch Times* and the *Washington Examiner* show up in my mail or on my driveway. It doesn't take careful examination to identify these sources as hyperpartisan, and I find it unfortunate that many people who read these don't bother to verify facts or look at the issues presented from another perspective. Efforts to unite the country will require that people be able to identify and reject misinformation and conspiracy theories. It has been interesting to observe how the social media companies are finally acting to curb some of the most egregious content on their platforms, and no doubt Congress will attempt to further regulate these popular communication platforms.

In addition to our voter education role, the League advocates on issues where our members have found consensus. Our state legislature is beginning its work in Tallahassee with committee hearings and will convene for its session in March. You will soon start receiving *The Capitol Report* and *Action Alerts* via email. Please prepare yourselves to take part in our advocacy efforts by participating in our Zoom Advocacy Training on February 10th. You will come away with the knowledge you need to effectively communicate with policy makers on issues of importance to you and the League.

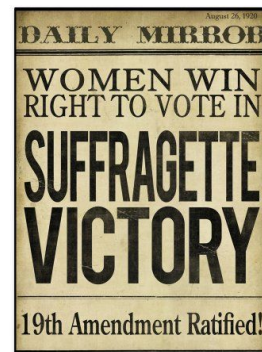
Annual Meeting March 22, 2021

Suffrage Anniversary Event Postponed

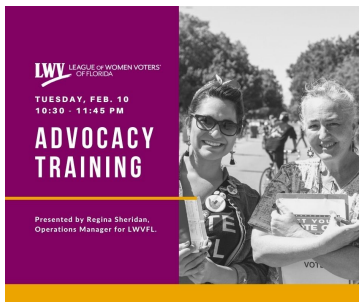

LWV The Villages – Tri-County Area Creates New Education Fund

The Board of Directors authorized the creation of a new 501(c)(3) non-profit organization that can accept tax-deductible donations to fund our voter education mission. We received notification in mid-January that the IRS

approved the application. Even if you do not itemize, you may deduct up to \$300 in donations to qualified 501(c)(3) organizations. Contributions may be made by check to LWVTRI Education Fund and mailed to our treasurer Bernadatte Aley at 1106 Monterey Lane, The Villages FL 32159. Previous donations were administered by the State Education Fund and they charged an administration fee. We will now have our own Education Fund!

I urge all people of good will to speak up against a potential health care crisis in Lake County. Anthony Sabatini, who represents part of Lake County in the Florida House of Representatives, has filed a bill (HB 257) seeking to overrule the will of voters and slash funding for medical care for thousands of Lake County residents. The proposed bill would end the North Lake County Hospital District Board and the funds it distributes for indigent care to local mental health clinics, urgent care centers, and hospitals.

In a 2016 Referendum, 59% of Lake County voters approved the continuation of the Board and its taxing authority for another 10 years. Sabatini refuses to honor that vote because he does not like taxes. The Board currently collects a tax of less than \$1 for every \$1,000 in real estate value, after exemptions. Lake County tax records show that Sabatini lives in a house in Howey-in-the-Hills assessed at \$203,559, and must pay less than \$12 per month in Hospital Board taxes.

According to July, 2019 figures from the United States Census Bureau, over 15% of Lake County residents under age 65 have no health insurance. That's about 40,000 people. Fortunately, Hospital Board taxes have provided a safety net for over 50 years for uninsured patients. Sadly, Sabatini seeks to destroy that safety net. Considering the growing number of people who have lost their jobs and their health insurance due to COVID, he is doing a real disservice to Lake County residents.

He claims that his colleagues serving Lake County in the Florida House support his bill. I urge Lake County residents to tell our Representatives to vote against HB 257 and keep the Hospital Board tax. Voter Services

If you would like to register voters with the League of Women Voters, you must be certified by the Florida League of Women Voters. Certification involves taking a test that has been developed by the State League, and passing it with a 100% score. Certification lasts for two years, from January 1, 2021 to December 31, 2022. Members who were certified in 2019 to 2020, have until March 1, 2021 to renew your certification.

To become certified or to renew your certification, go to our website, www.lwvtrifl.org. Place your cursor on Members Only, in the upper right of the page. In the drop-down box, click on Useful Info, then scroll down to Certification to Register Voters. Here you will find all of the instructions to access the study guide and the quiz.

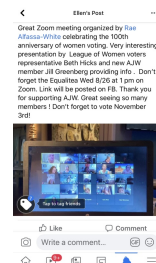
