Education

Mt. Dora Candidates' Forum A Young Man's Thoughts

Going into the Mt. Dora forum, I had expected to find an environment in which the candidates answered a series of non-specific questions with replies that were often riddled with tropes and clichés, and often resorted back to using the same rhetorical attacks and defenses, with little regard for substance or actual solutions.

Instead, what I found was something that was more reminiscent of a town hall or organization meeting, in which members of the community gave their ideas and opinions on ways to address specific problems and improvements within the community. Being so close to the candidates in such a small room helped remove the

"celebrity status" I had assigned them in my mind, and really helped humanize them. I think this humanization made the candidates a lot easier to read. You would often notice when a candidate was prepared and when they were not, when they really knew what they wanted to say when they didn't.

Overall, I found the experience very interesting, and I think those who are interested in politics as well as those interested in learning about and improving their local community would feel the same.
