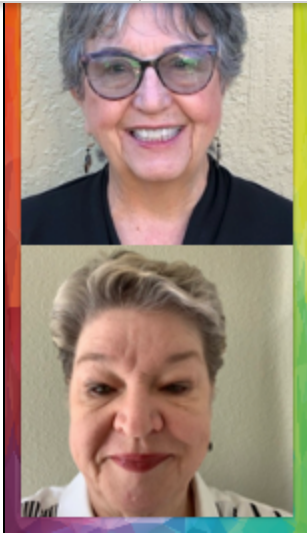

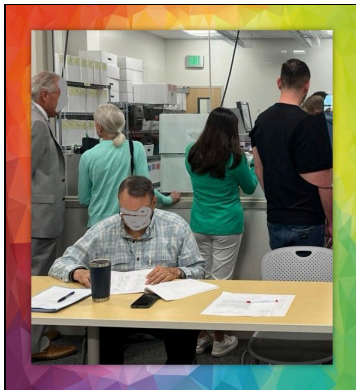
## What's a Canvassing Board?

Election security has become a hot topic. Last month I had a front row seat to witness the care the Sumter County Canvassing Board takes to balance having every legitimate vote count while ensuring voters are who they say they are.

What's a Canvassing Board (CB), you may be wondering.

While there are federal amendments and laws covering elections, each state administers elections differently. In Florida the [Canvassing Board](#) monitors and certifies election results. The Board consists of the supervisor of elections, a county judge, and the chair of the county commission.
