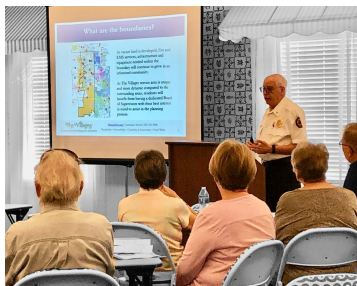
November General Meeting Monday November 21 10 AM Manatee Recreation Center

October General Meeting Recap

On October 24, 2022, over 40 members and community members attended the Village Public Safety Department's (VPSD) presentation on the referendum to establish an Independent Fire Control and Rescue District in the Sumter County portion of The Villages. Fire Chief Edmund Cain and Deputy Chief Jim Goodworth explained the history of this proposed change, what to expect if the referendum passes, and the funding formula defined in the referendum. Audience engagement was evident by the many questions that followed.

Members of VPSD staff brought computers and were available after the presentation to allow participants to see estimates of how much their taxes would increase if the referendum passes.

Board Meeting Highlights

We now have over 140 members. Ten years ago we had around 40. In the last two months we received 5 Contact Us forms from people who surfed the web, found our website, and reached out to learn how to join. We are a growing force in the Tri-County area.

Currently, the budget is prepared by a separate Budget Committee. Since the Board is elected to plan League activities and the budget is merely one part of the planning, the current procedure not only is unique to our League, it serves no purpose that we can determine.

We are planning a community event to be scheduled later next year. The topic will be related to the misinformation and disinformation we face as voter. More information to come!

MEMBERSHIP NEWS

.You can expect to have an email reminder from member chair Gail Formanack (formanag@gmail.com) prior to your anniversary date. Please pay your dues locally rather than joining directly with LWVUS.

Effective April 1, 2022, members may now renew their membership online and pay with a credit card. The link to the membership renewal page is <https://www.lwvtrifl.org/renew.html> You may also navigate to this from the main top menu "Become a Member." New members may register, current members may renew, and you can update your directory information if you have moved, have a new phone number, etc. Of course, you may still send a check through the mail to our treasurer, Bernadette Aley, 1106 Monterrey Lane, The Villages, FL 32159. Please fill out the member interest survey when joining or renewing. We would like to get you involved in an area of League work that interests you.

As of April 1, local dues have been increased by \$2.00 for individual (\$62) and household memberships (\$87). The amount retained by our local organization will increase from \$13.50 to \$15.50 (individual) and \$15.00 to \$17.00 (household). The Susan B. Anthony membership level includes a \$40.00 additional donation retained in the general fund so will remain at the \$100.00 level. This increase will cover the fees incurred when paying by credit card.
