## President's Letter

### **Happy 95th Birthday to the League of Women Voters!**

The League was founded on February 14, 1920 by Carrie Chapman Catt during the last meeting of the National American Woman Suffrage Association approximately six months before the 19th Amendment to the U.S. Constitution gave women the right to vote. The League began as a "mighty political experiment" aimed to help new enfranchised women exercise their responsibilities as voters. Much has been accomplished by League members since 1920, and there is still much work to be done.

With that in mind, the Legislative Session will begin on March 3 and the League will be concentrating on the following:

- Social Policy-Support implementation of the Federal Health Care Reform Law in Florida, emphasizing access for all and control of costs including Medicaid expansion and mental health coverage. Support the education of Floridians regarding application for coverage.
- Education-Support a free public education system for Florida's high standards for student achievement and with equality of educational opportunity for all that is financed adequately by the state through an equitable funding formula.
- Government-Support an open government that is responsive to the people.
- Natural Resources-Promote an environment beneficial to life through the protection and wise management of natural resources in the public interest by recognizing the inter-relationship of air quality, energy, land use, waste management and water resources.

During the course of the session, League members will be receiving emails recapping what transpired during the week. At times, you will be asked to respond to Action Alerts, and I hope you will take the time to do so.

Thank you to the members and guests who attended our January Program Planning Meeting. Many issues were discussed and the board will be meeting later this month to review the material in preparation for making recommendations at the annual meeting in March.

We are looking forward to welcoming Sheriff Gary S. Borders and Capt. Todd English of Lake County to our February general meeting. They will be speaking to us about human trafficking in the tri-county area. Delegates to the national League 2014 Biennial Convention in Dallas concurred with the already adopted position of the New Jersey state League. Below is that position:

*Human Trafficking: Oppose all forms of domestic and international human trafficking of adults and children, including sex trafficking and labor trafficking.*

*The League of Women Voters of New Jersey opposes all forms of domestic and international human trafficking of adults and children, including sex trafficking and labor trafficking. We consider human trafficking to be a form of modern day slavery and believe that every measure should be taken and every effort should be made-through legislation and changes in public policy-to prevent human trafficking. Prosecution and penalization of traffickers and abusers should be established, and existing laws should be strictly enforced. Extensive essential services for victims should be applied where needed. Education and awareness programs on human trafficking should be established in our communities and in our schools.*

Our Annual Meeting will be on Monday, March 23, at The Cottage Inn in Lady Lake. We are pleased to announce that in addition to the business of the meeting, we will also be celebrating Women's History Month as well as the League's 95th birthday. Our guest speaker will be Lauren Ritchie, columnist for the *Orlando Sentinel*. Her columns can be found in the Lake section of the paper as well as online. You are in for a treat!

### **Trip to The Villages Water Treatment Plant**

On January 20th, members of the League joined with members of The Villages Environment Club for an early morning trip to one of the water treatment plants which is located on Buena Vista Blvd. in The Villages. Because of The Villages' size and the amount of landscaping and golf courses, various methods of irrigation are used. There are three utility districts in The Villages and each utility district has its own reclaimed water system. We visited the North Sumter County Utility Dependent District and the main purpose of this district, as well as the other two, is to irrigate the many golf courses in The Villages using reclaimed water. The NSCUDD covers the area south of CR466 and will include the property being developed in Fruitland Park. The tour lasted about 45 minutes and we saw the process from beginning to end. ## **Nuclear Power Safety**

George Erickson, author and world traveler, member of the Thorium Energy Alliance and the Union of Concerned Scientists, and former VP of the American Humanist Assoc., spoke at the Jan. 6th meeting of the Civil Discourse Club in The Villages at the Colony Cottage Recreation Center. The title of his talk was Nuclear Power Safety. The following website was suggested for review as background for the talk:

<http://energyrealityproject.com/nuclear-power-climate-change-warrior-for-the-21st-century/>. Most of the points Mr. Erickson made can be found at that web site. Below are a few of them:

- Carbon pollution is a great danger to the environment. While nuclear energy is efficient and doesn't pollute the atmosphere, there are concerns about nuclear accidents and handling of spent nuclear fuel. This hasn't been helped by Chernobyl, Fukushima and America dodging a bullet with Three Mile Island. Yet overall, nuclear is still among the safest energy generating methods.
- Thorium nuclear power is a superior alternative to radiation nuclear power. Thorium is common all over the earth, and therefore cheap, and is more efficient (less hazardous) to mine. A lack of information, misinformation and, in some cases, deliberate deception have prevented its use.
- In the 1940s the uranium-based reactor was the nuclear reactor of choice because the plutonium that was produced was useful for making bombs. The Molten Salt Reactor which can use thorium does not produce plutonium and so was cancelled because it was not useful for making bombs.
- There is a prevalent misunderstanding that any amount of radiation is bad; however radiation occurs in nature and is present all around us. Low dose rates from natural radiation are not a problem over a lifetime. The effect of radiation is the same regardless of the source. Nuclear radiation is a tiny portion of all radiation exposure.

When asked what action the public should take, Mr. Erickson suggested that we ask them to fund research in the development of new types of nuclear reactors. More about George Erickson and titles of books he has authored can be found at <http://www.tundracub.com>.
