The Ethics Committee is happy to be sponsoring the November General Meeting with Ginger Delegal, General Counsel of the Florida Association of Counties.

Ms. Delegal is a frequent speaker and author on topics of interest to the local government community in Florida and has taught a fundamental class on the U.S. Constitution at Tallahassee Community College. She is a member of the Florida Bar, recently appointed to the Executive Committee of the City, County & Local Government Section of the Bar, and the State Bar of Georgia.

The committee is presently studying different ethics scenarios based on advisory opinions from the Florida State Ethics Commission. ## **Natural Resources Committee**



As Pat Grierson told us at our October meeting, the Florida Water & Land Legacy petition is reaching its needed number of signed, verified petitions. Unless Florida's voters approve a proposed state constitutional amendment on the 2014 ballot to guarantee funding to buy and protect important parts of the state's remaining undeveloped conservation lands, it's doubtful they'll ever be preserved, former state Sen. Rick Dantzler said recently.

If this amendment makes it to the ballot and is approved by 60% of the voters, it

- will provide state funding for the purchase and maintenance of conservation land throughout Florida.
- will ensure that our cherished beaches, rivers, lakes, springs and forests are protected for future generations.
- will direct one-third of existing state revenues from "documentary stamps" to fund restoration and conservation projects in Florida's most critical water protection areas and lands. This measure WILL NOT increase taxes, nor will it increase state funding. It simply allocates a portion of the existing documentary stamp tax (paid when real estate is sold) to water and land conservation, management and restoration.
- will reinforce Florida's long-standing leadership on water and land conservation.


