Happy New Year! I am sure many of us are happy to close the door on 2020 while looking ahead to better times in 2021. Until the vaccine is available and protecting the majority of our members, we will continue to meet virtually via Zoom. The Florida Legislature will begin committee meetings in January in preparation for the session which begins March 2<sup>nd</sup>. Most committee meetings will be held virtually, however three rooms have been reserved at the nearby civic center for larger, in-person meetings. In preparation for the legislative session, our League is asked to conduct interviews with our local representatives and senators to help identify supporters of our issues. The LWVFL lobbying firm, Capital Alliance Group, predicts the focus of the session will be on bringing the economy back and dealing with a \$2.7 billion budget shortfall. With input from local Leagues, the state League has narrowed our legislative focus to four priorities which have the greatest chance of having an impact. Please follow the link to the [legislative priorities](#). However any bill, even outside the priorities, that seems to impact our issues can be addressed by action of the state board. Testimony at most committee hearings will be virtual this year. Our paid lobbyists will stay in the background, and we will rely on testimony from our Lobby Corps, issue chairs, and state board members.

You will have an opportunity to learn advocacy strategies during a virtual Advocacy Training conducted by Regina Sheridan, a Florida League staff member. This meeting will be devoted to the 2021-22 Program planning process. The League is a grassroots organization, and every year prior to our Annual Meeting held in March, we hold a program planning meeting which affords members the opportunity to have input on the issues that matter to you. In League vernacular, “program” is the process of study and advocacy of issues and is a core component of our mission. Our program positions consist of issues selected by local League members, and our local advocacy is based upon these positions. League members review and adopt them annually in March. The state and national Leagues follow the same process at their bi-annual conventions.

As you review the [2020-21 Program](#), you have a few options:

- Suggest a new topic for study
- Suggest a review of a current position for a possible update
- Suggest an amendment to an existing position or suggest deleting an item if it is no longer relevant

In generating ideas, we ask you to consider the following guidelines:

- Is there widespread member interest?
- Is this a timely issue?
- Is local government action needed to address this issue?
- Will League involvement make an impact?
- Do political realities permit effective action?

The board will consider all input provided during the January meeting and will propose a program for adoption at the annual meeting in March. We hope you will take the time to carefully review the current program and bring suggestions for changes or additions to the January meeting. ## This Bill Hurts



I was dismayed to hear that State Rep. Anthony Sabatini introduced a bill to eliminate the North Lake County Hospital District. This taxing district levies an annual tax (a small portion of our property tax) to support six clinics and two hospitals in North Lake County. This money is used to offset the cost of medical care to our indigent population. These clinics work on a shoestring budget and are staffed primarily by volunteers. Without the funding to provide this medical care, the uninsured will go to hospital emergency rooms for basic health care. Without this funding, these clinics would close. With emergency room costs going up due to uninsured visits, our hospital costs may go up. The small amount we pay now will offset what could be a major increase in our personal medical costs.

This tax not only provides important services to our indigent population, it keeps our hospital costs stable. I do not support Sabatini's bill and neither should our community.

## One Person CAN Make a Difference

There was a front page article in the **Orlando Sentinel** 12/26/2020 with the headline **Bill lets counties protect tenants.** State Senator Dennis Baxley, R – Ocala, is sponsoring Senate Bill 290, allowing county commissions to set up boards focused on landlords accused of violating the state laws that prohibit retaliatory conduct such as by raising rent, not renewing leases, or issuing evictions to tenants who have reported code violations, joined unions for

tenants, or legally withhold rent until repairs were made.

The story goes on to say this is an issue that housing advocates say has become more widespread after the Coronavirus pandemic hit.

Inspiration for the bill comes from the plight of **Leesburg resident Marie Wissler** who was nearly evicted from her rent-restricted apartment for

complaining about needed repairs.

Baxley, who says he usually “always with the property owners” said of Wissler’s situation:

“Somebody needs to be on her side of this discussion and when somebody’s a complainer you don’t get to just throw them out and have nobody who can question it” he said. “There needs to be a fair forum where you can make your case.”

*[When **now retired Lake Sentinel columnist Lauren Ritchie** was apprised of Wissler’s situation, she wrote a column about what appeared to be an injustice and published an interview with Wissler on her on-line blog.]*

**Lake County School Board Member Bill Mathis** responded to Wissler’s plight by helping her find a prominent lawyer who would fight her case in court *pro-bono*.

The article goes on to say that “*in a state where landlord and property management groups have powerful lobbyists, it’s unclear how the bill will be received in the Legislature.*”

**Sean Parks, chairman of the Lake County Commission**, said he would support the creation of such a board and believes other commissioners would, too. In the past five years, he said he’s seen more situations like Wissler’s, but there’s been little the county can do.”

“There are some landlords and people in property management in Lake County that do have a reputation,” he said, “and I’m sure it’s like that all over the place.”

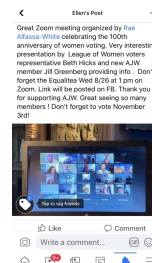
