No more robocalls, flyers filling up the mail box and negative ads telling us what is wrong with the other candidate. The reported amounts of money spent in the state and across the country are obscene.

During her travels this selection season, LWVUS President Elisabeth MacNamara said that "The DISCLOSE Act and Citizens United have been major topics on the road. The latest flap about the Chamber of Commerce seems to miss the key point that regardless of whether the Chamber collects dues from foreign-owned corporations, the Chamber is making the largest campaign expenditures in history while refusing to disclose its donors. The point is that secret money has no place in American elections. The voters deserve to know who is speaking to them through these ads. The irony is that the very media outlets that should be and, in some cases, are reporting on these secret expenditures are accepting the advertising money. With the DISCLOSE Act mired in Congressional infighting, the only recourse that voters have is to educate themselves and vote, in large numbers." There is plenty of blame to go around on both sides.

Here on the local level, we did our best to inform and educate with speaking engagements and distribution of the special election edition of "The Florida Voter."

I would like to take the opportunity to especially thank **Dr. Charles Mojock**, president of LSCC, **Ron Shearer** and **Jerry Fenoff**, LSCC TV for providing the facilities for the League to tape forums on Amendments 4 and 8. Both presentations were excellent, and our participants provided solid positions on both sides.

Two of our study committees, Education and Transportation, are gearing up again. Please read both pieces from Bernice and Charlene.

Note the change in date for our November meeting, and make it a point to attend. This is where the "ground up" voice of the local League is heard.

## **PROGRAM PLANNING MEETING**

Program Planning is not to be confused with the special programs (speakers, panel discussions, etc) that are presented at our regularly scheduled local League meetings.

On the state level, members of local Leagues come together to discuss issues of statewide interest and current or potential League

concerns. Members (you and they) recommend issues for study and action. Our board determines level of interest in those recommended issues and sends the results to LWVF board. State program is derived from the input of all local Leagues. This same process will take place on the local level in preparation for our Annual **Meeting** in 2011.

On Monday, **November 8**, at **10 a.m.** you have the opportunity to discuss the LWV State Program and decide what we want to remain in that program and what we might want to add (i.e. transportation) or subtract. Currently the **State Program for 2009-2010**, adopted 2 years ago at the state convention includes:

- 1. Government in Florida** - State Constitution, Finance & Taxation and Election Law
- 2. Education in Florida** - funding to provide equitable & quality education
- 3. Justice in Florida**
- 4. Social Policy in Florida** - Health Care financing & delivery, jobs/equal pay for equal work
- 5. Sustainability**
- 6. Natural Resources** - preservation and conservation and energy via renewable sources

There you will see a link to **"Study & Action 2009-11."** **Pages 2-5** explain the Program Planning Process as well as explaining the current program for LWVF. Please print these pages out and bring them with you to our November 8 meeting. **Betsy Brody** and **Charlene Walker** will walk us through the process.

In addition, Charlene will explain the transportation study which the delegates to the 2009 LWVF Convention approved and bring us up to date on it. As the problems related to it have not been resolved, we may want to add Transportation to the 2011-12 state League agenda. Also, you might want to consider other local or state issues that you would want to suggest to the state League for a new study. There are many possibilities!

## **TRANSPORTATION STUDY: WHY WE NEED IT!**

The Robert Wood Johnson Foundation is a philanthropic organization dedicated to improving the environment and the lives of children and families. Their recently completed research gives a myriad of reasons why we should be concerned with transportation planning. Here are just a few. For a more comprehensive look at this research, visit their website, <http://www.rwif.org>.

Two new resources released by *Active Living Research*, a national program of the Robert Wood Johnson Foundation, examine the relationship between investments in active transportation, physical activity and obesity rates, and the extent to which regions across the country are making such investments.

*Making the Link from Transportation to Physical Activity and Obesity* summarizes the most up-to-date research showing that transportation investments encourage healthful activity. The brief details how increasing access to public transportation, making streets and sidewalks safer, and developing trails and bike lanes impact people's health and how much they bike and walk for transportation. Among other findings, the research brief concludes that public transit use is linked with higher levels of physical activity and lower rates of obesity.

In 1984, the LWW Orange County Transportation Committee initiated a study of transportation and land use planning in the metropolitan Orlando area. As chair, I gave the following statement developed by that committee and presented, in various forms, to county and city commissions, MPOs, legislative delegations and state legislative committees since 1984.

"Planners and engineers too often make moving the automobile their primary, and frequently the only, planning objective. Comprehensive planning is only given lip service. Proof abounds that poor planning creates environmental and human disasters and government's accountability to the people continues to avoid addressing that proof.

We must find a way to make comprehensive planning and implementation a reality instead of creating plans that include bikeways, sidewalks, public transit, park & rides, HOV lanes - to be built sometime in the future - if there are any funds available - and after we build just that one more road that will solve all our problems - and after we have covered Florida with asphalt.

The social consequences alone of such poor planning robs those unable to drive a car - the elderly, young, handicapped, homeless and poor - of the accessibility to critically needed transportation and independence.

To quote Andreas Duany and Elizabeth Zyberk, who are architects and builders of livable communities, 'The chief criterion of town design, in our history, is the flow of automobiles. The chief concern is getting the cars through quickly. Now, cars and people are not incompatible; most of the beautiful cities have cars and people together. But when the cars are given precedence, then the people don't fit.'"

Please volunteer to help with our local transportation study. We can impact what is done in the tri-county area.

## **WHAT IS HAPPENING TO EDUCATION**

### **IN AMERICA?**

Diane Ravitch is a historian of education, an educational policy analyst, and former United States Assistant Secretary of Education who is now a research professor at New York University. She is a graduate of Wellesley College, has a Ph.D from Columbia University, and lives in Brooklyn, New York.

Ravitch has written numerous books on education her newest book: "The Death and Life of the Great American School System: How Testing and Choice Undermine Education" (2010) became a surprise best seller a month after its release. She critiques the punitive uses of accountability to fire teachers and close schools, as well as replacing public schools with charter schools and relying on superstar teachers. While she originally supported No Child Left Behind and charter schools, she became "disillusioned," and wrote, "I no longer believe that either approach will produce the quantum improvement in American education that we all hope for."

Our **Education Committee** would like to invite you to join us on an adventure to investigate "Race To The Top," the administration's education policy and how it will play out here in Florida. ## **VOTERS SERVICES COMMITTEE**

What did the League do during this election season?

- ✓ We sponsored two forums that were taped at LSCC TV on Amendments 4 (growth management) and 8 (class size limits). Both of these forums aired numerous times on LSCC TV.
- ✓ Our candidates and issues forum, which was cosponsored with AAUW, was held on October 6, and we were pleased that all of the local candidates for school board and the county commission from Marion County were in attendance in addition to the candidates for the Lake County commission. Also in attendance was a representative for Rich Nugent who is

campaigning to replace Rep. Cindy Brown-Waite. Rep. Alan Hayes, who is running to replace Sen. Carey Baker, was also present. Last, but not least, Bob Jenner, a candidate for the Lake County Water Authority Board of Trustees, District 2 presented his case. As you can see, there were no candidates present from Sumter County. The reason? There was only one contested race in the August primary and that was for the school board. None of the commissioners up for reelection had opposition in the primary.
