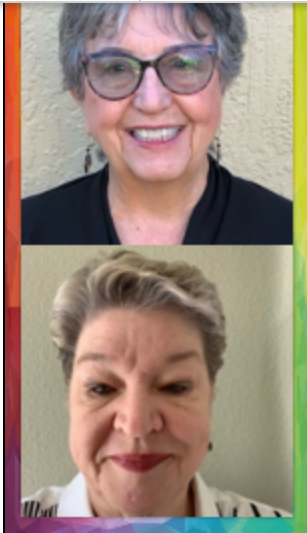

## Important Year Ahead

LWVTRI has important work to do in 2024. It's a presidential election year, which coincides with important races, such as Supervisor of Elections, County Sheriff, School Superintendent, and Clerk of Courts, which only appear on the ballot every 4 years. These races are in addition to the other offices on the ballot every two years (e.g., judicial, county commissioners, mayors, city councils).

Do voters have the information they need to make informed decisions in these local elections?

While an all-time high of 72% of eligible Florida voters cast a ballot in 2020, that means 28% did not. What can be done to activate the individuals who chose not to participate?

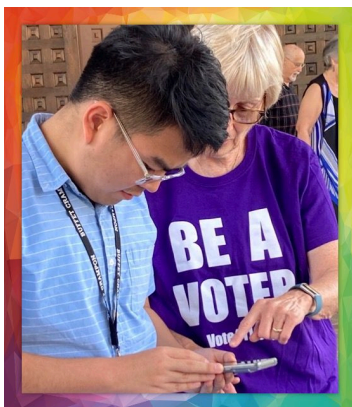
## If It's Information You Want

on the budget at the Annual Meeting in March.

We also discussed contingency plans for an anticipated drop in income of approximately \$1,000 when LWVUS starts collecting dues in January 2025. Under the new system our members will pay dues directly to LWVUS, and they will reimburse LWVTRI 20% of that payment.

Currently, many of our members renew at the Susan B Anthony level (\$100 for individuals; \$125 for households.) Their generosity gives our local League an additional \$38 over the dues we receive. Under the new system LWVTRI would only receive an additional \$5 if individual members selected a \$100 tier.

Stay tuned for Board plans to keep our budget in balance.
