### **President's Letter**

It is hard to believe that we just had our first General Meeting of 2014 and it is time to resume our work as League members. We have busy months ahead of us!

We started off 2014 with a visit from Rep. H. Marlene O'Toole at our January meeting. Every seat in the room was taken by League members and guests. With an emphasis on education, Rep. O'Toole outlined her priorities for the 2014 Session which begins in March. This was an informative meeting, and we are grateful to Rep. O'Toole for taking us through the route she has to follow to generate a bill and shepherd it through the process to, hopefully, passage by both houses of the legislature. As she pointed out, it is not as easy as you might think!

I hope you have two of our upcoming meetings on your calendar. We are very excited about our February and May meetings. In February, we will be meeting at the Sumter County Government Building on CR466A and Powell Rd., Wildwood. We will be celebrating the League's 94th birthday, and joining us will be Leslie Burch, Interim Library Services Manager, Sumter County Library System, who will be updating us on the outsourcing of the operations of the library system.

Additionally, we are happy to be welcoming Rep. Wilton Simpson, District

18, to his first meeting with our League. Sen. Simpson was elected to the Senate in 2013, and his district encompasses all of Hernando County, a portion of Pasco County and all of Sumter County with the exception of The Villages. We are hopeful that Sen. Simpson will address legislation he is working on involving water issues. After hearing both presentations and before the celebration begins, we will be developing our local program for the coming League year which begins April 1.

In May, three of our League members who live in Lake County will be hosting League members and guests at a covered dish luncheon meeting on May 19, at the Waterwood Community Clubhouse on Lake Harris in Yalaha. ***Carpooling is a must*** and we are in the process of working out those details. Our guest speaker will be J.T. Glisson. Author and artist, Mr. Glisson was raised in Cross Creek and was a neighbor of Marjorie Kinnan Rawlings. In fact, he was the boy with the clubfoot in Rawlings' book, *Cross Creek*. Mr. Glisson will be talking about his book, *The Creek*, describing his day-to-day life growing up. Mr. Glisson will have copies of *The Creek* for purchase at the luncheon. In preparation for this meeting, it is recommended that you read *Cross Creek*.

March will be our Annual Meeting at which time we will elect our board, and approve a budget and program for the coming League year. Our guest speaker will be the Hon. Alan Gold, retired federal judge, who will speak about campaign financing. With this being an election year, the topic is very timely and of great concern to the League.

April will be devoted to the discussion of water issues, and in June, Karen K. Krauss, Supervisor of Elections, Sumter County will be our guest speaker. The timing for this meeting is perfect as Primary Elections will take place in August.

As you can see, we have a few busy months ahead of us, and even though our general meetings end in June, we will still be busy with our speaking engagements and the publication of our Voters Guide 2014.

### **The Politics of Water**

Since the 1920s and 30s, the League of Women Voters United States has studied and established positions on resource management. The overarching position is "Promote an environment beneficial to life through the protection and wise management of natural resources in the public interest." This provided impetus for the League to build "a broad national program focused on protecting and managing the interrelated aspects of air, land use, energy and waste management.

As state and local Leagues were established, the League has been in the "...forefront of the environmental protection movement, helping to frame legislation and seeking to preserve and protect life-supporting ecosystems and public health." Public input opportunities are a cornerstone for the League.

Another water issue of interest is the Floridians' Clean Water Declaration Campaign. The Floridians' Clean Water Declaration Campaign is a collaborative effort driven by dozens of civic and environmental organizations from around the state. The groups, of which the League Women Voters of Florida is one, are coming together to create a force for change - a change in the water policies of the state of Florida. By sharing ideas and resources across stakeholder lines and watersheds, we will be stronger - stronger together to command our right to clean water.

you will find a declaration to sign. Among the rights and responsibilities mentioned in the declaration, are: clean drinking water, safe lakes, streams, protection from water pollution, water privatization, etc.

## **Voter Service & Education Committee**

It is time for our Voters Service and Education Committee to focus on the coming election cycle and our speaking engagements.

Changes to Florida's campaign spending limits, potential amendments to our constitution, and voter identification rules will be focal points for our first presentations this year. We already know that there will be two amendments: one dealing with dedicated funding for water and land management and the other, medical marijuana. Changes to Florida's laws dealing with legalized gambling have been discussed as possibly appearing on the ballot in November if a joint resolution is passed by three-fifths of the membership of each house of the legislature. In addition, there is talk about an amendment on term limits.

Our first speaking date of 2014 will be Saturday, February 8, in Mt. Dora and our Speakers Bureau is hard at work preparing for that engagement.

## **How A Bill Becomes A Law**

With the start of the 2014 Legislative Session just a month away, it is good to know how a bill becomes a law in Tallahassee. As Rep. O'Toole alluded to in her presentation on January 27, it is not all that easy.

- Either house may originate any type of legislation.
- A legislator sponsors a bill which is referred to one or more committees related to the bill's subject.
- The committee studies the bill and decides if it should be amended, pass or fail.
- If passed, the bill moves to other committees of reference or to the full house.
- The house votes on the bill.
- If it passes in one house, it is sent to the other house for review.
- The same process is followed in the second house as it did in the first house.
- The bill can go back and forth between the houses until a consensus is reached.

As League members, we will be called upon by the state League's advocate during the session to contact legislators concerning certain pieces of legislation. Please respond.
