Royal, founded in Sumter County after the Civil War when freed slaves were given 40 acres and a mule, is one of only two homestead communities remaining in the U.S. This historic land has been passed down through the generations. Our guest speaker, Beverly Steele, will share that rich history with us as well as current efforts to have Royal added to the National Register of Historic Sites.

CO-PRESIDENT COLUMN: Structural Changes to LWVTRI



Our national League, LWVUS, is launching a new membership system in late January or early February. When this happens, we will no longer be collecting your dues; LWVUS will.

This change requires a change to our local Bylaws as well as the responsibilities of the Board - particularly those of the Treasurer and Membership Director.

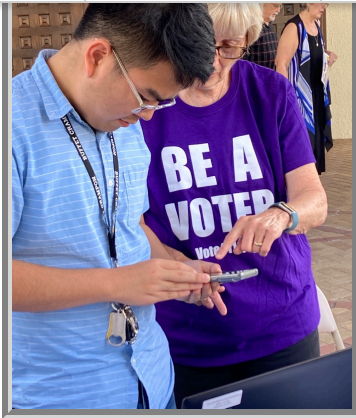
In preparation for these changes, the Board has been reviewing how we operate. In the process we worked with a consultant from LWVUS and learned we do not need the complication of running two organizations: LWVTRI, a 501c4, and LWVTRI Education Fund, a 501c3.

As a result, the Board recommends we merge LWVTRI, the organization in which you are a member, into LWVTRI Education Fund. This surviving 501c3 will be named League of Women Voters of The Villages / Tri-County Florida.

We need your approval to merge. You received an email on December 3, asking you to vote. If you have not done that already, please do that now by completing this short [form](#). Our current Bylaws require that at least 20% of members participate in this decision.

VOTER SERVICES: Keeping Voters Informed



Sumter Counties in 2024?

We have received a report from the League of Women Voters US, who developed the Vote411 software. The report tells the number of people who used Vote411 from January 1 to November 5, 2024, in all Florida locations. This [chart](#) lists all of the locations in our three counties. The total listed is 15,412 users, but that accounts only for those who live in the listed cities. There are additional users in Lake, Marion and Sumter counties who do not live in any of the listed cities. What a great success!!

Speakers Bureau: We currently have one scheduled presentation on January 25, 2025, at the Leesburg Public Library. We will have many more during 2025. The Speakers Bureau is a great opportunity to hone your skills and defend democracy by educating voters, at the same time. Plus, it is fun to meet people and to learn about other organizations.

Voter Registration: We currently have no scheduled voter registration events. The major topic for 2025 will be to urge those who vote by mail to request a vote by mail ballot so they will be able to vote by mail in the 2025 and 2026 Elections. We have applied for a grant to contact young voters, so we will be going to all of the College Campuses in this area. We have also applied for a grant to provide information to former felons, so we will be addressing postcards to former felons who have not registered to vote. If you would like to register voters, inform vote-by-mail voters that they must renew their request or address postcards to former felons, please contact [Carol Van Noy](#).
