1. A state ban on all semiautomatic assault weapons and large-capacity feeding devices
2. Comprehensive universal background checks and ensuring that the State provides all relevant records to the FBI's National Instant Criminal Background Check System (NICS)
3. Continuing efforts to defeat unsafe gun legislation, such as Open Carry, Campus Carry, and Stand Your Ground expansion.

Are you interested in a particular area of league concern: national resources, juvenile justice, voting rights, popular vote, etc. but not ready to take over a committee? I have an easy way for you to learn more about your area of interest and dip your toe into the water of involvement. Most groups have monthly conference calls. ### Tales from Tallahassee

Jake and Diana Bishop attended the 2018 LWV Florida Legislative Summit in February, and enjoyed two full days of training, discussion and advocating on LWV issues.

At the end of the second day a recognition dinner took place, and it was interesting to hear the success stories. One success story was a local League who far surpassed their quota of signed ballot petitions. Another was League members from Seminole County and solar power co-ops. The women who initially knew nothing about solar were able to successfully put together a co-op of 60 participants and are in the process of starting a second co-op. This is happening around the state. These are only two examples of the power of the League Members working together on an issue. We came away with a much more optimistic view of what can be changed.

All attendees were welcoming and helpful. The process of educating new people was very thorough. This was our second time attending and was as educational, if not more, than the first. This year's attendance of 200 members was one of the largest yet, and we would recommend anyone with the time and energy to attend.

## Education

Visits to VPK providers in the tri-county area are winding down as we complete another part of our examination of Florida's VPK program. This joint project between our League and Lake/Sumter AAUW has been under way for three years.



In the current phase of the project, 18 volunteers are going in teams of two to observe VPK classrooms in action and to interview each program's director and VPK teacher. To date, we have visited 18 programs in the tri-county area, with each visit lasting at least three hours. After each visit, the two visitors prepare four reports: a director interview report, a teacher interview report, an observation checklist, and an observation narrative. It's easy to see that each of our volunteers put in many hours of work for each observation, and most volunteers completed at least two site visits.

In earlier phases of this project, volunteers were involved in designing the observation and interview forms, participating in pilot testing of our materials and procedures, and helping to revise them as needed. For this final phase, in addition to those volunteers who are conducting site visits, several others planned and are carrying out the analysis of the information collected. A report based on this information will be issued in late summer or early fall.

As we approach the end of our process of learning about VPK, we would like to take this opportunity to thank everyone who was involved. In all, 25 volunteers from our two organizations have contributed to the project: We could not have done it without them. And now we are looking forward to the Annual Meeting and reporting on the VPK consensus meeting which was held in January.

## Voter Service

Our Speakers Bureau now has a new Coordinator: Jeannie Hamilton is now accepting requests for speakers. Thank you Jeannie!! We continue to speak to groups, about: the Constitution Revision Commission (CRC), which is in the process of holding public hearings to decide which proposals to place on the 2018 General Election Ballot; the Restoration of Felon Rights, which will be on the 2018 Ballot; and two other topics are in our future. We have a Power Point Presentation for the National Popular Vote Interstate Compact, which is an initiative in the development stages, to urge states to agree to instruct their Presidential Electors to vote for the candidate who received the most votes, nationwide, instead of in their state. After all of the Amendments to the Florida Constitution have been filed with the Florida Secretary of State, we will prepare a Power Point Presentation explaining the proposed Amendments and the pros and cons of voting for them. If you belong to a group who would like to have a speaker on one of these topics, please contact Jeannie Hamilton. Or, if you have speaking experience and would like to volunteer to speak for the League, please contact Carol Van Noy.

Florida is one of the States in the Public Advocacy for Voting Rights (PAVR), which is researching compliance with the Motor Voter Laws. In 2017, Janis Dorgan and Janet Duncan, interviewed the

Department of Motor Vehicles (DMV), in each of the three counties, Lake, Sumter and Marion and found them all working hard to implement the State's Motor Voter Law. The PAVR now wants us to send members whose licenses are due for renewal to their local DMV Office, and report back whether they were offered the opportunity to register to vote. If your drivers' license is due for renewal, and you are willing to go to your local DMV Office, please contact Carol Van Noy to volunteer.

Ellen Dugan has volunteered to implement a Voter Registration Drive. Thank you Ellen!! Ellen and Carol will meet with the Supervisors of Elections in the three counties and ask what we can do to help them. Once we know their needs, we will make a plan and Ellen will implement it. If you are interested in Voter Registration, please contact Ellen Dugan.

Webmaster Charlene Griffin and Carol Van Noy are again preparing to develop the 2018 online Voters Guide. For the first time, we will use VOTE 411, a software program sponsored by the US League. The program offers the voter a ballot specific to their address and the ability to compare candidates for the same office. We still must contact the candidates and urge them to give us the information that we need for the program. If you are interested in researching candidate contact information, please contact Carol Van Noy.
