I'm looking forward to working with you this year!

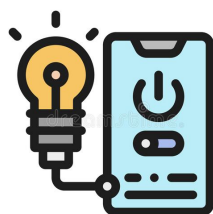

Voter Services

VOTER REGISTRATION:

Thanks to all of the members who have taken the time to read the State League Materials and take the State Quiz to be certified to register voters. We have had great success with the Lake Sumter State College drive and are still working on scheduling voter registration dates at Central Florida College, in Ocala.



We have an upcoming voter registration event, scheduled on Juneteenth, Saturday, June 18, 2022, from 9:30 to 4:30, in Ocala. In the next week, I will recruit volunteers for this event.

We are collecting pledge cards from all of the people we register, as well as from those already registered to vote who stop by our table. When we publish Vote411, in July for the Primary and in September for the General, we will call, text or email all of the people for whom we have pledge cards to tell them about Vote411, early voting, Vote by Mail and to urge them to vote.

Co-Chair Needed: We need a volunteer to manage the voter registration activity, while I manage the Candidate Information portion of Vote411. That member would recruit members, from those who have been State Certified,

to staff the Voter Registration Events that are suggested by the Youth Registration Project and the Community Events Coordinators; designate the shifts for each event; send the necessary instructions to members who will staff those shifts; and coordinate with Jeannie Hamilton the materials to be taken to each event; and collect and retain completed pledge cards. In July and September send email from League Gmail account or texts from the State Voices vehicle, to registered voters who completed pledge cards, announcing publication of Vote411 and encouraging them to vote.

VOTE411:

Training: During April, I will recruit volunteers to collect candidate information for Vote411. We will hold training for Sumter and Lake County volunteers in early May.

Develop Questions: In May, we will begin working on questions to be asked candidates in Vote411. We will ask the volunteers who take the Vote411 Training to provide questions for us to ask the candidates. Our candidates will be County Commissioners, School Boards, City Councils, Mayors, Water and Soil Districts, and Villages Community Development District Supervisors. If you have suggested questions for any of these positions, please send them to me: denny.carol@gmail.com.

Technical Assistance: We need someone to help with the technical end of Vote411, i.e., setting up the races, importing the Candidate Information Spreadsheets, helping candidates upload photos, etc.

BOOK REVIEW ~ Kathy Porter

***My Beloved World* by Sonia Sotomayor**

As I watched the Senate confirmation hearings

for Ketanji Brown Jackson, and was so very impressed by her comportment as she acquitted herself beautifully despite baseless attacks on her judicial record, the hearings brought to mind the fascinating autobiography of Justice Sonia Sotomayor. I knew that had to be my choice for this month column.

Justice Sotomayor writes in a candid, often humorous style, and gives us an intimate look at her life. Born in 1954, she is of Puerto Rican descent and grew up in the projects the South Bronx with an alcoholic father and her mother, a nurse. Diagnosed with juvenile diabetes at the age of seven, she began giving herself daily insulin injections.

Her relationship with her mother was often distant and became more strained after her father died when she was nine. The light in her life was her paternal grandmother who gave her “protection and purpose.” However, it is her mother’s love of education that nurtured Justice Sotomayor’s desire to excel.

The following quote epitomizes the essence of Justice Sotomayor. “There is indeed something deeply wrong with a person who lacks principles, who has no moral core. There are, likewise, certainly values that brook no compromise, and I would count among them integrity, fairness, and the avoidance of cruelty.”

My Beloved World details Justice Sotomayor’s exemplary life and career, and should be at the top of your reading list. The book reinforces the fact that we are so fortunate to have such an exceptional justice as Sonia Sotomayor on the U.S. Supreme Court.

As of April 1, local dues have been increased by \$2.00 for individual (\$62) and household memberships (\$87). Anthony membership level includes a \$40.00 additional donation retained in the general fund so will remain at the \$100.00 level. This increase will cover the fees incurred when paying by credit card.
