### JANUARY MEETING: Senate Bill 180's Impact on Local Government

State Senate Bill 180 which became law in 2025 and is now in effect in Florida, has been a point of controversy for local governments. The bill was meant to help with post-disaster recovery but some counties and municipalities are concerned that it makes recovery more difficult. Mayor Homich will explain the concerns and how the bill might be amended or changed to address those concerns.

### CO-PRESIDENT COLUMN: Stop Partisan Gerrymandering



Partisan gerrymandering is illegal in Florida. Despite what other states (Texas, California, Louisiana, etc.) may do, Florida has an explicit prohibition in its constitution on partisan map making, and Florida legislators have all sworn an oath to support and defend both the U.S. and Florida Constitutions.

However, Governor DeSantis has asked the Florida Legislature to redraw the current maps to create more congressional districts

Republicans already hold a disproportionate share of seats: although only 41% of Florida voters are registered Republicans, they comprise 71% of the state's congressional representatives.

This suggests a technique known as "[cracking and packing](#)" was used to establish the current districts and could be employed again to create non-competitive districts that ignore population demographics and local government boundaries.
