### President's Letter

The Presidential Primary is March 15, and once that is over, it won't be long until the activity in candidate filings for county, state and national offices starts to pick up.

Because of redistricting, Congressional and state Senate district lines have changed, and with that a game of "musical chairs" has begun:

- Rep. Richard Nugent will not be seeking reelection; one of the candidates who will be running in the Republican Primary is Rep. Daniel Webster whose district boundaries have changed. Rep. Webster doesn't feel he could be elected in the new district so he is running for District 11 which will encompass all of Citrus, Hernando and Sumter counties in addition to portions of Lake & Marion counties.
- Sen. Alan Hays will not be seeking reelection to his Florida Senate seat; instead he has filed to run for the Republican nomination for Lake County Supervisor of Elections.
- Rep. Dennis Baxley, who represents Marion County and who had previously indicated that he would be running for the seat held by Sen. Charles Dean, has changed his mind and decided to run for the Republican nomination for the recently redrawn District 12 Senate seat that includes all of Sumter County and portions of Lake and Marion counties. Rep. Marlene O'Toole, is term limited, and has indicated that she will also seek the Republican nomination for Senate District 12.

On the local level, there will be filings for school board, county commissions, county charter offices and, in The Villages, Community Development District Supervisors. And this is just March!

Once again, our League will be preparing an online Voters Guide not only for the August Primary but also for the November General Election. With much thanks to Char Griffin, Beth Hicks & Carolyn Van Noy for their hard work on past guides, your help will be needed. Voter education and service are the core principles of the League, and without your help we cannot succeed. In addition to the guides, we already have speaking dates scheduled, and your participation is essential to our success.

The day following the Presidential Primary, the League will be joining with other organizations to celebrate Women's History Month at Lake Sumter State College on Wednesday, March 16. The guest speaker will be Genean Hawkins McKinnon from the Florida Commission on the Status of Women. In addition, Emogene Stegall, retiring Lake County Supervisor of Elections, will be honored for her many years of service. We hope you will join us at this event.

We invite you to join with the League in welcoming Pamela Goodman, LWV Florida President, to our Annual Meeting on March 21. With just two more weeks left in the 2016 Legislative Session, Ms. Goodman will be speaking about the work of the League during the session as well as other League activities. If you haven't made your reservation for the Annual Meeting I urge you to do so.

As we end one League year in March and begin a new one in April, many thanks to all of you who have made our League what it is today. Our membership continues to grow and involvement in League projects is increasing. We continue to learn about our community and state through our informative general meetings.

The Florida Commission on the Status of Women is a nonpartisan board, statutorily created in 1991, consisting of 22 appointed members. The Commission is administratively housed in the Office of the Attorney General. The Governor, the Speaker of the House of Representatives, the President of Senate and the Attorney General appoint four members and the Chief Financial Officer and Commissioner of Agriculture each appoint three members for a term of four years.

The Commission's mandate is to study and make recommendations to the Governor, Cabinet and Legislature on issues affecting women. These recommendations are presented in the form of an annual report that is distributed in the first quarter of each

To vote at an Early Voting site or at a polling place on Election Day, voters are required to present current and valid photo and signature identification. Two forms of identification may be presented if one form contains the voter's photo and the other form contains the voter's signature. Below are acceptable forms of identification:

- Florida driver's license
- Florida identification card issued by HSMV
- U.S. Passport
- Debit or credit card
- Military identification

- Public assistance identification




## FROM LWVF
