### **Co-President's Corner**

***100 years ago, women didn't have representation in government.*** The League of Women Voters US has asked all local Leagues to join in a **"Day of Action"** on **February 14, 2020** which marks the **100th Anniversary** of the founding of the

League of Women Voters. Because that date is the sad anniversary of the Parkland school shooting, the Florida League has asked its local Leagues to observe this day on **February 13th**. As part of the national **"Women Power the Vote"** campaign, the **LWV of The Villages/Tri-County Area** will officially launch our **"Be a Voter"** campaign targeting young women in our area through social media. We hope to garner the attention of the traditional media with our campaign while informing the public of the League's anniversary and our continued efforts to increase voter participation. All members will be asked to help spread our **"Be a Voter"** message through any social media platforms you use or with personal conversations with young women you encounter in your daily activities. Business cards with the **"Be a Voter"** message will be available at meetings to hand to people and direct them to our videos and other voting information on our website. Please be prepared to help spread the word in our local community.

Our **February 24th** general meeting will feature a presentation on the history of women's suffrage given by League member **Char**

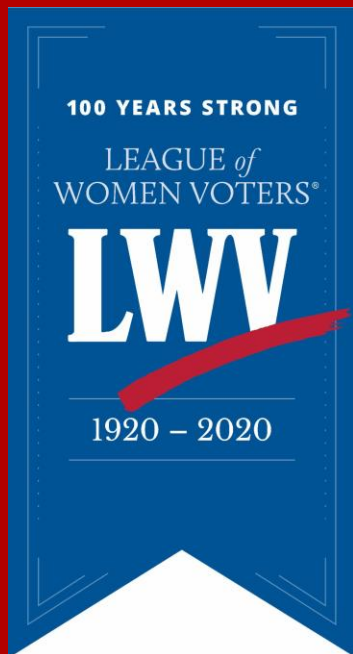
**Griffin**, and we will honor our local organization's charter members. We hope you will come celebrate the 100th birthday of the League, complete with birthday cake! If you are unfamiliar with the rich history of the organization, the following is a brief synopsis of how it all started 100 years ago as taken from the LWVUS website. The League of Women Voters was founded by Carrie Chapman Catt in 1920 during the convention of the National American Woman Suffrage Association. The convention was held just six months before the 19th amendment to the U.S. Constitution was ratified, giving women the right to vote after a 72-year struggle. The League began as a "mighty political experiment" designed to help 20 million women carry out their new responsibilities as voters. It encouraged them to use their new power to participate in shaping public policy. From the beginning, the League has been an activist, grassroots organization whose leaders believed that citizens should play a critical role in advocacy. ***It was then, and is now, a nonpartisan organization.*** League founders believed that maintaining a nonpartisan stance would protect the fledgling organization from becoming mired in the party politics of the day. However, League members were encouraged to be political themselves, by educating citizens about, and lobbying for, government and social reform legislation.

This holds true today. The League is proud to be nonpartisan, neither supporting nor opposing candidates or political parties at any level of government, but always working on vital issues of concern to members and the public. The League has a long, rich history, that continues with each passing year.

### **Voter Registration Credentials**

Just a reminder to League members who are certified to register voters, as well as League members who would like to be certified to register voters, that as of **December 31, 2018**, the certification of all voter registrars expired. League members who do voter registration for the League will need to re-certify their credentials with the State League **ASAP**. Beginning in 2017 the LWVFL instituted a 2-year cycle whereby the list of approved voter registrars would be wiped clean, requiring members to re-certify. The two-year cycle ended on 12/31/2018.

If you are interested in doing voter registration with our League, you must study the PowerPoint which is on the LWV Florida website and take the quiz, attaining a perfect score. Once you pass with 100% you will get a notification from LWVFL that you are authorized to do voter registration. ### **2020 Legislative Session**

The Florida League has hired a new lobbying firm to assist the many individual issues chairs in monitoring the bills filed and moving through the legislature this session. Weekly reports will be shared to inform members about bills affecting the League's priority issues. Following our local League's study on



the quality of Voluntary Pre-Kindergarten programs, we will especially be monitoring bills filed to improve the quality and funding for early childhood education programs.

LWVTRI members **Gail Formanack, Bonnie and Bob Field**, and **Connie Treadway** are registered to attend the **LWVFL Lobby Days** in Tallahassee scheduled for **February 4-5**. In addition to the educational sessions, the attendees hope to visit personally with senators and representatives from our local area. Check the March newsletter for a complete report.

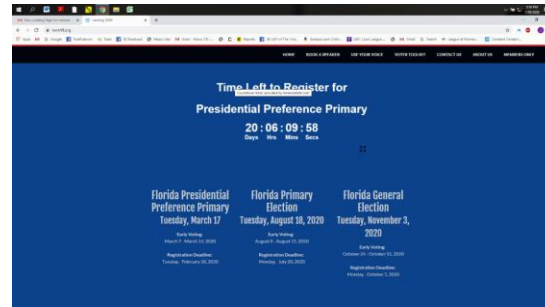
The drop down menu from the Top-Nav allows you to go directly to the page you want to access.

## Voter Service

### **Speakers Bureau**

Since March 2019, the Speakers Bureau has made presentations to 21 organizations and more are being scheduled.

Below are some of the topics for which our League is providing speakers:

### **Balance of Power: 3 Branches of US Government**

The Constitution of the United States divides the federal government into three branches to ensure a central government in which no individual or group gains too much control. This presentation describes the powers of the Legislative, Executive and Judicial branches of the federal government and how they relate to one another.

### **Electoral College & National Popular Vote Interstate Compact (NPVIC)**

This presentation explains the origin and function of the Electoral College and what some states are doing to change how we elect the President and Vice President of the United States to reflect the popular vote.

### **2020 US Census**

The 2020 census will mark the first time people will be able to respond to the census online as well as by phone and mail. Census results help determine how the federal government will distribute billions of dollars among states, counties and local governments. The census affects legislative redistricting at all levels of government and determines how many seats in Congress each state gets. This PowerPoint explains the 2020 census and why it is important that everyone responds to help Florida compete for these benefits.

### **Your Voice. Your Power. Your Vote.**

In 1776 only 10% of Americans had the right to vote. Learn the history of expanding voting rights and the important benefits to those who turn out and vote. This presentation describes the ways voters can register and vote which includes registering online, Vote by Mail, early voting and more.

### **The Fight for Women's Suffrage**

The year 2020 marks the 100<sup>th</sup> anniversary of the ratification of the 19<sup>th</sup> Amendment to the U.S. Constitution giving women the right to vote. This PowerPoint describes the sacrifices of activists

whose tireless efforts from 1848 to 1920 culminated in women's suffrage.

### **Women's Suffrage 101:**

#### **It's suffragist, not suffragette**

As we prepare to celebrate the 100<sup>th</sup> anniversary of the 19th Amendment, confusion has again surfaced about the term "suffragist" versus "suffragette." The correct term to refer to advocates for the right to vote is suffragist, not suffragette. In fact, suffragette was considered a derogatory term in the U.S. women's suffrage movement.

The terms suffrage and enfranchisement mean having the right to

vote. Suffragists are people who advocate for enfranchisement. According to the National Parks Service and other sources, reporters covering the suffrage movement took sides. In 1906, a British report used the word “suffragette” to mock those fighting for women’s right to vote. The suffix ‘ette’ is used to refer to something small or diminutive, and the reporter used it to minimize the work of British suffragists according to the NPS. The term remained offensive in the U.S. and was not embraced by the U.S. suffrage movement. Instead, the term “suffragette” was used by anti-suffragists in their fight to deny women in the United States the right to vote.

### **LWVTRI Legislative Education & Action Committee**

We had a busy agenda for our last meeting prior to the LWVFL Lobby Days. Our learning process is moving along. Our agenda included a review of the bills our Lake, Marion and Sumter legislators have filed. We looked at the bills to determine which bills are among the League's priorities for tracking. A handout of a few of the acronyms commonly used in the Legislature was provided, and a peek at the full glossary of terms with their meaning was also available. Additional helpful web sites were identified.
