## **Co-President Notes Gail Formanack**

As 2021 winds to a close, I continue to read with interest the unsubstantiated claims of voter fraud by former and current office holders. We are over a year past the election, and it is alarming to see signs that these claims will become part of the campaign messaging for our 2022 elections. According to the Wall Street Journal (November 24, 2021) some

local election chiefs have been harassed and subjected to intimidation for refusing to say the vote counting isn't secure. Unfortunately, the message appears to be contributing to eroding confidence in the nation's election systems. In October, a Grinnell College poll found that 58% of Americans were very or somewhat confident that the 2022 vote will be counted fairly. Confidence among Republicans was at just 38%, down from 85% in March 2020.

Irritated by Lake County Republican leaders who want a forensic audit of the 2020 vote and who allege the "entire election system is fraught with flaws," Elections Supervisor Alan Hays — a long-time member of the GOP — posted a rebuttal on his official website recently, demanding they "PUT UP OR SHUT UP!!"

"As an election professional, I find it disturbing that some of our citizenry continue to promote a narrative that is unsubstantiated in fact or example," he wrote. "It begins with the unrelenting desire to believe that an election was 'stolen,' and that 'the vast majority of us witnessed (this) on election

night 2020.'

Our League will be hearing from Alan Hayes at our February meeting and will look forward to more information on the election situation locally. In any event, the 2022 election cycle may prove to be challenging for multiple reasons. The League is offering presentations on the impact of SB 90, the election reform bill passed earlier this year. If you know of a community group who might be interested, please contact our Speakers Bureau chair, Jeannie Hamilton.

## November Meeting Summary



Those who attended our November general meeting enjoyed a wonderful presentation on Redistricting by Frank Costanzo. His engaging style impressed and inspired our members. Mr. Costanzo represents “All On The Line,” a 501c(4) campaign to bring citizens across every issue together to win on redistricting in 2022. Their mission includes raising awareness about the harmful impact gerrymandering has on federal and state policymaking.

Mr. Costanzo explained that some elected officials use the redistricting process to gerrymander or “pick their voters”. He stated that following a census, states redraw their congressional, state legislative, and other district boundaries to ensure equal, proportional representation. That process is called redistricting. With gerrymandering, a political party or other group can gain power without actually winning a majority of the vote. He stated that gerrymandering during the redistricting process is used to establish a political advantage by manipulating electoral district boundaries.

According to Mr. Costanzo, there is a solution. We need to increase public engagement in the redistricting process to advocate for fair and transparent maps. In 2010, voters approved “Fair Districts” Amendments 5 and 6 to the Florida Constitution. These prohibit line drawing that intentionally favors or disfavors a political party or an incumbent and protects racial and language minorities.

In 2012, the Florida state legislature intentionally ignored the “Fair Districts” amendments and passed gerrymandered maps. We learned from Mr. Costanzo that after years of litigation, new court approved Congressional and state Senate maps were in effect for the 2016 elections. The House maps are still gerrymandered. He explained that there are no statutes requiring public hearings specifically for redistricting, but the state’s legislature has traditionally held hearings across the state before the session that maps are drawn. We need to remain vigilant as the maps are created so this doesn’t happen again. Even with the Fair Districts Amendments, gerrymandered maps may still be submitted. We need to establish and maintain fair maps for fair voting state-wide.

The first half of the meeting will feature a presentation by Sam Delgado, ACLU's Statewide Voting Right Organizer. He will talk about ways to improve voter access in our tri-county area.

The second half of the meeting will be devoted to **member input on our local program**. This is an important part of our grassroots organization as we work to incorporate your ideas into the program statements. The League is a grassroots organization, and every year prior to our Annual Meeting held in March, we hold a program planning meeting which affords members the opportunity to have input on the issues that matter to you. In League vernacular, “program” is the process of study and advocacy of issues and is a core component of our mission. Our program positions consist of issues selected by local League members, and our local advocacy is based upon these positions. League members review and adopt them annually in March. The state and national Leagues follow the same process at their bi-annual conventions.

As you review the 2021-22 Program, you have a few options:

- Suggest a new topic for study
- Suggest a review of a current position for a possible update
- Suggest an amendment to an existing position or suggest deleting an item if it is no longer relevant

In generating ideas, we ask you to consider the following guidelines:

- Is there widespread member interest?
- Is this a timely issue?
- Is local government action needed to address this issue?
- Will League involvement make an impact?
- Do political realities permit effective action?

The board will consider all input provided during the January meeting and will propose a program for adoption at the annual meeting in March. We hope you will take the time to carefully review the current program and bring suggestions for changes or additions to the January meeting. ## Board Meeting Highlights

Board Highlights – November and December meetings

- The board decided no raffle at holiday lunch in lieu of suggested donations to the LWVTRI Education Fund.
- Discussed plans on community program called “Conversations for Changes.”
- Location and speaker were finalized for annual meeting

- Treasurer Bernadette Aley is moving treasurer’s records to Quicken, and she prefers to hold off on the use of Square for payment of dues
- Initiated a discussion and survey on the effectiveness of the “Be a Voter” videos. Board was asked to locate alternative video resources suitable for a social media campaign.
- The board approved the recommendation of an ad hoc technology committee to spend up to \$1500 to purchase a new laptop, virus protection, hot spot, and audio equipment to be used at speaking and voter registration events.
- The results of the member survey were discussed, however a relatively low number of members responded. More attempts to gain input will be made.
- Carol Van Noy was given permission to submit a LWVUS Youth Voter Registration grant proposal targeting registration at colleges in the tri-county area.

## Election Integrity

**Wesley Wilcox of Marion County** is the President of the Florida Supervisor of Elections and that organization has sent out a plea urging Floridians to ignore the disinformation and misinformation that so readily available and to check the Supervisor of Elections website in their county of residence for information about Florida elections. He points out that these dedicated public servants are working tirelessly to ensure the security and integrity of our elections. And, the Governor and Secretary of State acknowledge that Florida Elections are run with integrity and are automatically audited.

## Legislative Update

The Florida Legislature convenes January 11, and the 60-day session will end March 11. The LWVFL lobbying firm, Capital Alliance Group, will put out regular emails to members allowing us to track bills on which the League has taken a position. With input from local Leagues, the state League has narrowed our legislative focus to six priorities <https://lwvfl.org/legislative-session/>

which have the greatest chance of having an impact. Please follow the link to the legislative priorities. However, any bill, even outside the priorities, that seems to impact our issues can be addressed by action of the state board. Our paid lobbyists will stay in the background, and we will rely on testimony from our Lobby Corps, issue chairs, and state board members. The League is a grassroots organization and relies on its members to answer “Calls to Action” by contacting your legislative representatives.
