We sincerely hope to gather in person for our October meeting. Please keep an eye out for reminders and any update as to the status of this meeting, in person or virtual.

Vilia Johnson will be speaking on Ranked Choice Voting. Ranked choice voting allows voters to rank candidates by preference in all general elections. Initially votes are tallied as normal, with only first choice votes being counted. If no candidate receives a majority of votes, the candidate with the fewest votes has their votes moved to voter's next choice. This process repeats until a candidate receives a majority of all counted votes. Votes removed with no alternate assignments are not counted.

Vilia Johnson serves on the Board of the League of Women Voters of Sarasota County where she is Team Leader for the Election Reform and Advocacy Committees. She also serves on the Board of Rank My Vote Florida.

What is Home

Rule/Preemption

Some states constitutionally or legislatively grant home rule to cities, counties, and municipalities within their borders. These are called "home rule states." Local governments in home rule states are free to pass laws and ordinances as they see fit to specifically meet their unique needs. Florida voters added Home Rule Powers to the Florida Constitution nearly 50 years ago by a statewide vote of the electorate. Home Rule means local decision-making. As long as it doesn't violate state law, cities and local governments have the flexibility and independence to serve their citizens' needs and preferences.



Over the past few years, the Florida Legislature has attacked the Home Rule authority of local governing bodies. The Florida League of Cities says it's because some legislators think they know your community better than the local officials you elected. Our Florida legislators continue to pass preemption bills, and LWVFL has opposed those actions based upon the principles of local government. These legislative bills circumvent local decision-making and trample on the individuality of each city, town, and county government. In the past three legislative sessions alone, more than 100 preemption bills were filed. Some examples include the preempting of local rules banning the use of plastic bags and plastic straws and other environmental protections passed by local municipalities. Closer to home, we saw an example when Sumter County commissioners voted to raise impact fees for road development. This action was promptly followed by the introduction of a bill in the Florida Legislature to cap increases to impact fees. The bill, co-sponsored by local Rep. Bret Hage, passed the legislature and overturned the decision of our locally-elected officials.

The most precious powers a local government in Florida has are its Home Rule powers. These bills impede the ability of locally elected leaders from enacting ordinances and codes, fundamental to governance of municipalities and counties.

And, five of the seven winning candidates of all of the races participated in the Ocala Meet and Greet.

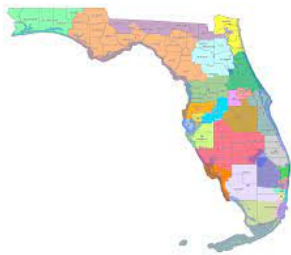
We can be truly proud that we offered Ocala voters excellent opportunities to get more information about the candidates and they responded.

Redistricting

Florida is in the middle of drawing new district boundaries for the U.S. House, the Florida Senate, and the Florida House. This happens every 10 years after the Census.

In 2010 Florida voters passed the Fair Districting Amendment in 2010 to ensure fair districts. It requires districts

- be of equal size
- be compact
- adhere to political and geographical boundaries
- exhibit partisan fairness
- exhibit minority fairness

Nonetheless, the districts created by the Legislature in 2012 broke every rule with the exception of equal size. The League filed suit to get the gerrymandered districts redrawn. The judge said the maps made a mockery of the democratic process.

This year both the data and the map drawing tools the Legislature uses are [available](#). You can submit your maps for consideration, or at the very least better understand the challenges of drawing fair maps.

The districts created by the Legislature and approved by the Governor will impact your life for the next 10 years at both the national and state level. Be vigilant. Be informed. Be involved.

Local Program Statement on “One Sumter”

Monitor and support the repeal initiative for “One Sumter” and return to county commissioners elected by those residing in their districts.

The above statement was adopted by members at the 2021 annual meeting. In recent action taken by the Sumter County commissioners, it appears Sumter County voters will be given an opportunity to vote on repeal of “One Sumter” opening the possibility of a return to the election of commissioners by only the voters in their geographic district. It is likely to be opposed by The Villages Developer as it was initially passed to ensure the county’s greatest population center in The Villages would have more influence in electing those representatives to the county commission. Our mission will be to educate voters about the implications of this ballot item.

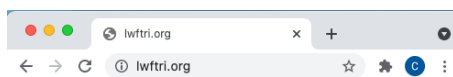
Ends Health Care for the Needy



In a 3 to 2 vote, the North Lake County Hospital Board put a sad end to the health care clinics for our uninsured and underinsured citizens. The board voted for a millage rate of zero which ended the tax we pay (usually about \$10 to \$15 a month) to support six clinics in North Lake County. The funds were allocated to six community health clinics to offset their expenses for treating those who were unable to pay. These clinics work on a shoestring budget and are staffed primarily by volunteers. Any monies left after funding the clinics went to our two hospitals to reimburse them for indigent care. In 2016, 59% of Lake County voters approved a Referendum to continue the Hospital District and its taxing authority for ten years. The board couldn't get rid of the District through legislation, so they did the next worst thing... approved a millage rate of zero.

I would like to personally thank those LWV members who worked to support these clinics and try to prevent the board from voting for zero millage. Kudos to Melody Duckins, Diane Grayber, Phil Grayber, Jane Hepting and Karen West for their efforts. We wrote, we spoke, we called, we rallied and showed up in large numbers to let the board know we voted for this taxing district and we wanted to continue the funding for those who are less fortunate. Though we were unsuccessful, we will develop a plan of action to bring funding back for such important health care
