We are living through interesting times as we all face growing concern over the spread of the Coronavirus. The board deeply regrets the cancellation of our LWV-The Villages/Tri-County annual meeting, however we felt it the wise decision to make given the increased risks to our older population. I hope you all had the opportunity to participate in our “virtual” meeting and took the opportunity to vote on our program, budget, and slate of officers. It certainly doesn’t replace the opportunity for face-to-face discussion and interaction, and we all hope

our regular activities will be able to resume soon. With the cancellation of the annual meeting, we missed the opportunity to publicly thank our out-going officers who have served our organization so well. At our last meeting, we thanked Joanne Coen, vice-president and communications chair, for her many years of service to our group. Joanne moved to the Washington, D.C. area in March and will remain an active League member there. The board will appoint someone to fill the remaining year of her term. We also thank Kathy Hansen who has served as secretary for the last four years and as a board member prior to that. Her attention to detail in the minutes has been a great gift. Lastly, we thank Beth Hicks for her service as president of our group for the last four years. Under her leadership, the League has moved from a small “member at large” group to become an official organization. As I write this column, we are still waiting for the final assessment of the legislative session. Despite fierce opposition from the League, the legislature passed further restrictions on the citizen’s initiative process. This will be one of the bills discussed at our next “Dine & Discuss” meeting. We will provide a brief synopsis on important bills tracked by the League and have a discussion. The meeting had been scheduled for April 14<sup>th</sup>, but we will move it forward to a future date yet to be determined and let you know.

I hope you will join us at a League-sponsored pre-release screening of a PBS documentary on women’s suffrage. This will be followed by a panel discussion featuring Jill Moss Greenberg, Katina Stephens, and Lisa French. The event had been scheduled for April 21<sup>st</sup> but will be rescheduled for a

later date. All recreation centers in The Villages are closed until further notice due to the virus, and we were notified that all April bookings have been cancelled. Our regular meeting scheduled for April 27<sup>th</sup> is cancelled and won't be rescheduled. We hope to meet as planned on May 18<sup>th</sup>. I hope you stay well in the interim.

Turnout at the polls on for the presidential preference primary was down from 2016 largely due to three factors: lack of a competitive GOP race, virus concerns, and a surge in early voting and vote by mail. We are asked to encourage early voting and vote by mail options. The League sent a letter to each of the Supervisors of Elections prior to the March 17<sup>th</sup> election and requested adding new sanitizing measures. Many League members who worked or observed at the polls reported these measures were largely in place. The legislative session ended on March 19<sup>th</sup> with the passage of the budget. It included the addition of emergency funds related to health care and economic recovery from COVID-19. There is already discussion they may have to reconvene to pass additional economic recovery measures. From the League's perspectives, there were some wins and losses. Two bills we fought hard to defeat but which passed anyway include parental consent for abortion and a bill that essentially guts the citizen's initiative process. Wins include school safety, health care for children, teacher pay, and retention of funds for affordable housing in the Sadowski trust fund. There will be some debriefing with the lobbying firms and issues chairs prior to the staff issuing a final report on the legislative session.

Due to the COVID-19 virus concerns, the state League's leadership conference was canceled. Please watch for notification on webinars that will be offered to any League member on some of the topics planned for the conference including diversity, election security, and others. If you can't tune in to the webinar live, they will be available on the website. Our state president said all person-to-person voter registration events must be suspended until further notice. It is recommended we send people to register through the League's [VOTE411.org](https://VOTE411.org) so we can track data on the number of those registered.

## **VOTER REGISTRATION**

Some dedicated members of our League of Women Voters Tri County have been busy registering new voters. We have registered voters at the Benevolence Center (Leesburg), Rotary Service Day, the AIMS Program (Lifestream), Open Door (Eustis) and the Leesburg Food Bank. So far we have

registered 20 people. Several were felons who had completed their terms and legal financial obligations. Unfortunately several events had to be canceled due to virus precautions, but these will be rescheduled when it is safe to do so. ### **Voter Registration Credentials**

Just a reminder to League members who are certified to  
register voters, as well as League members who would like to  
be certified to register voters, that as of **December 31,**  
**2018**, the certification of all voter registrars expired. League  
members who do voter registration for the League will need  
to re-certify their credentials with the State  
League **ASAP**. Beginning in 2017 the LWVFL instituted a 2-  
year cycle whereby the list of approved voter registrars would  
be wiped clean, requiring members to re-certify. The two-  
year cycle ended on 12/31/2018.

If you are interested in doing voter registration with our  
League, you must study the PowerPoint which is on the LWV  
Florida website and take the quiz, attaining a perfect  
score. Once you pass with 100% you will get a notification  
from LWVFL that you are authorized to do voter  
registration. To begin the certification process, please contact

Member link on the state League website.

## **NATURAL RESOURCES REPORT**

Our LWVFL Committee Chair, Judith Hushon has provided  
us with the following information on her conference call:

SBo712/HB1343 - Water quality improvement bill which the  
League had been following closely - passed. The League's  
view on this bill changed when the bill had items deleted  
from it concerning BMAPS and lack of agricultural polluter

reforms. The bill does contain mitigation for red tide and algal blooms in southern Florida and along the coast . The League joined with other supporters and requested amendments to improve it before voting - but were unable to improve the bill. This will be acted upon again in the next Legislative session.

SB7018/HB0943 - Electrical Vehicle charging stations on all FL State Hwys. Infrastructure - passed. The League had supported this bill. It also contains Florida Legislators conclusions regarding the necessity of alternate sources for transportation fuels to reduce carbon emissions , thereby reducing the negative effects of climate change . The wording on page 2 of bill 7018 is a BIG step in the advancement of carbon emission reductions.

HB1061/SB1042 - is another good bill. It creates the "Nature Coast Aquatic Preserve" to be included in the aquatic preserve system.

SB0178/HB0579 - concerns public financing of coastal construction. It requires a DEP study to develop sea level impact prior to the Government funding for the project.

There were multiple bills concerning the Land Acquisition Trust Fund which did not pass....however the funding for Florida Forever was approved for \$100 million.

HB1091/SB1450 was also supported as it requires counties in Florida to set up sewer systems. There is accountability and substantial fines for leakages into water ways.

Our next phone conference call is scheduled for May. We will be discussing talking points for : climate change, fracking, water issues, and preemptions by the State.

## **OBSERVERS OF FL LEGISLATIVE PRIORITIES**

Bills filed by our elected officials in  
Lake, Marion, & Sumter Counties

We have changed our group's name to better clarify our task.  
The prior name , Legislation & Education was a bit  
confusing.

The League had some of their priority legislation pass during  
this session: the Sadowski Fund for Affordable housing was  
not " swept", a good Clean Water Bill was passed, the Florida  
Forever fund is to be provided with \$ 100 million for  
conservation purposes, alternate energy sources, including  
Electric Vehicles ( EVs ) are to be studied and promoted by  
the State of Florida.

Most importantly in the EV, Bill 7018 , the Legislature has  
acknowledged :

(a) Climate change may have significant impacts to this state  
which will require

The development of avoidance, adaptation, and mitigation  
strategies to address  
these potential impacts on future state projects, plans, and  
programs:

(b) A significant portion of the carbon dioxide emissions in  
this state are  
produced by the transportation sector:

(c) Electric vehicles can help reduce these emissions.

A watered down version of E Vote bill was passed, and  
funding for teacher's salaries  
and school safety were approved. Unfortunately there were  
priorities not passed which the  
League advocated for. This means more effort is needed by  
LWVFL and all of the local  
Leagues to continue our efforts.

Next month we will be reporting on the Bills proposed or co-  
sponsored, which passed or  
died, that were initiated by our State Legislators in Lake,  
Marion, & Sumter Counties.

If you choose to explore these opportunities of learning and  
sharing.....it will require

simple research on your computer. Some of you may choose to visit and observe/report on County commissioner's meetings or even visit with your elected officials. What you decide to do is up to you. We hope you would join us.

Our website, **LWVTRIFL.org**, has a **Members Only** section containing multiple pages:

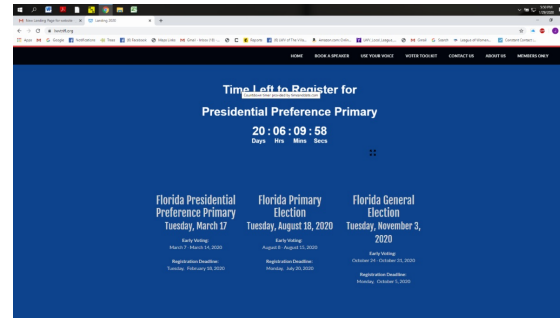
- the main **Members Only** page has our membership list, minutes from our last Board meeting, an Expense Voucher, our chapter's By-Laws as well as other information
