## **President Notes**

### **Gail Formanack**

The busy election season is now behind us, and we can feel very positive about our accomplishments in helping to facilitate a record voter turnout. Historically, the U.S. has some of the worst turnout rates in the world. Voters turned out at just over 50% from the 1970's until 2000 when political parties and advocacy groups began mobilizing voters. This year, Florida had a 77% turnout rate which was the highest since 1992.

Additionally, many of our members participated in the outreach campaign to encourage newly eligible former felons to register and vote. Almost one-third of those eligible (all fines and fees paid) did get registered. Others were put into contact with pro bono attorneys who were trained by the League to assist in determining their outstanding obligations and steered toward charitable organizations who are willing to assist them financially.

As we wait for the electoral college to meet and finalize the presidential race, we were fortunate to be able to learn about a movement to tie a state's electoral votes to the winner of the national popular vote. Kathleen Crampton, chair of the Floridians for National Popular Vote, provided us with a clear explanation of the electoral college and what the change would mean should it be passed in enough states to exceed the 270 electoral vote minimum. If you missed the presentation, you can find it on our League's Facebook page.

## OBSERVER'S NOTES

Legislative Observers Well, that was quite the election! Our new Representatives in the Florida House have been sworn in.

Welcome to the new folks

- Lake County District 31 Rep. Keith Truenow
- Marion County District 20 Rep. Yvonne Hayes Hinson
- Marion County District 22 Rep. Joe Harding

All other incumbents won their races, and the Florida Senate terms are 4 years - so no election for Sen. Keith Perry or Sen. Dennis Baxley. The only change was in Marion County where Jennifer Bradley replaced Sen. Rob Bradley.

Session starts March 3rd and ends April 30th this year, with committee work starting full swing in January.

Predictions by the new Florida Senate President, Sen. Wilton Simpson, in the Orlando Sentinel indicate the following areas will be priorities:

1. The elimination of the State's no fault auto insurance option
2. Increased money for Florida Springs \*
3. Replacement of septic tanks by sewer systems
4. Conforming the Budget to mitigate Covid 19 revenue loss ( thru 2022 expected loss of General Revenue - \$5.5 billion )

### VOTER SERVICES

#### CONGRATULATIONS TO ALL OF OUR VOTER SERVICES VOLUNTEERS!!

Now that the election is over, we look back on what we did and what we accomplished. Thirty of our members wrote postcards to registered voters, urging them to vote. We also sent letters to Sumter and Marion County Senior Facility Administrators and Activity Directors, urging them to help their registered voter residents to request, complete and hand deliver vote-by-mail ballots. All of these Get-Out-The-Vote efforts no doubt contributed to the record turnout in the 2020 General Election.

And, the Vote411 2020 Post-Election Report shows that there were **958,338 sessions, in Florida**, on Vote411.org! This is a **436%**

**increase over the 2016 cycle** (the most comparable cycle) and a 49% increase over the 2018 cycle. The Report further states that we saw the usual surges on the 2020 Primary date, but for the 2020 General Election, we saw a surge in September, a sustained higher level of users through September and October and then a much smaller surge on Election Day. COVID-19 and the change in how voters participated in the process this year were the reasons for these changes. This early surge in users shows that the voters listened to the League's messaging encouraging voters to vote early and to vote by mail instead of waiting until Election Day this year! September 2020 was so different as compared to the previous General Election cycle that we recorded a **200% increase in sessions this September as compared to September 2018!**

We are proud of all of your tireless work!! Thank you for your contribution to maintaining our democracy.

## Natural Resources

The election is over - the dust has settled. I think it important to be aware of the words spoken recently in the Orlando Sentinel by the new Florida Senate President, Sen. Wilton Simpson, regarding his priorities for the upcoming legislative session.

Sen. Pres. Simpson is changing the previous thinking that the method to reduce pollution of the Everglades by adding larger overflow reservoirs to the south of Lake Okeechobee - be replaced by mitigating pollution on the north side of the Lake. It remains to be seen if all the organizations monitoring Florida's clean water efforts will agree? It will also be interesting to see how and with what funds he will support the transition from septic tanks to sewer systems in Florida. Most folks agree and have advocated for years that is a necessary step to maintain Florida's

clean drinking water. Florida's natural Springs which are a major source for our clean drinking water will also benefit. Sen. Wilson wants additional funding, above the \$50 million mandated by law. This also will be welcome news for the groups which advocate for our Springs.
