January General Meeting

At our meeting on **January 23**, our guest speakers will be two League members from the Orange County League, **Michelle Levy** and **Ann Hellmuth**. They will present a program on the state League's Open Primary Study.

Florida has one of the lowest primary election voter turnout rates in the country. In 2015, the League began the Open Primary Study, the purpose of which is to evaluate the current closed primary system in Florida to determine whether it is a hindrance to voter turnout. The state League Study Team has been investigating a wide range of alternate voting systems and researching reasons for and solutions to low voter turnout to accomplish this purpose. Our League members will be participating in a consensus meeting concerning this study. This will be an excellent opportunity to learn more about this issue and how the League studies an issue in order to determine whether or not to take a position on an issue.

Michele Levy retired as a social worker for the state of Florida after 30 years. She worked with adults and children with development disabilities. She then ran her own training and consulting company for 5 years. She was co-president of the Orange County League of Women Voters for 3 years. She now chairs the statewide study on Open Primaries. **Ann Hellmuth** is a retired journalist who worked for newspapers and wire services in England, South Africa, Canada and the United States. After retiring as deputy managing editor of the Orlando Sentinel, she joined the League of Women Voters of Orange County and later served as president. She also served on the League's state board.

Online Voters' Guide

Thanks to **Carol Van Noy** and **Char Griffin**, our mission to educate voters was enhanced with our online voters' guides. We had our busiest day on October 24 when there were 1,523 visitors. The rest of the days prior to the election averaged about 200 hits. Since the election, we are averaging about 100 visitors a day. In regards to how did people find our site, the largest number came from the state League's site. A large bloc was also from Google Searches followed by a small number from villages-news.com. 2017 Florida Legislative Session

During the course of the Florida Legislative Session, which will begin on **Tuesday, March 7, 2016**, and go for 60 days, League members will receive a weekly online "**Capitol Report**" which is prepared by the League's lobbyist in Tallahassee. This is a newsletter which describes legislation pertaining to LWVF legislative priorities and gives tips on when and how to take action.

In addition, **Action Alerts** are sent to local League members when local lobbying can play a critical role and when member interest and knowledge are high enough to produce an effective response. Local Leagues are urged to take the action requested in the Alerts in the name of their local League or as an individual members as appropriate. State level positions come from the study and consensus of individual League members, so local League support can prove very effective in lobbying on these positions. Make your voices heard in Tallahassee when you are asked!

2017 Florida Constitutional Revision Commission

Beginning in January 2017, the Florida Constitution Revision Commission will begin scheduling public hearings to be held throughout the State, in order to develop proposed Constitutional Amendments for the 2018 General Election Ballot. Every 20 years, the Commission is appointed to

1. Examine the Florida Constitution;
2. Hold public hearings throughout the State; and
3. Recommend changes to the Florida Constitution for voter consideration.


The Commission will be composed of: 15 members appointed by the Governor; 9 appointed by the Speaker of the Florida House of Representatives; 9 appointed by the President of the Florida Senate; 3 appointed by the Chief Justice of the Florida Supreme Court; and 1 appointed by the Florida Attorney General. This Commission can offer changes to the Constitution that omit current provisions or add new provisions. For example, the last time the Commission met, in 1998, the Commission proposed Revisions to Article IX, Education, which included limiting class sizes, permitting adjacent counties to combine school districts and permitting counties to give the school board power to appoint the superintendent, which requires a vote of the county registered voters.

At our **December 12, 2016** and **January 23, 2017** meetings, we will have available ***Citizens' Guides to the 2017-2018 Commission***, so you can suggest and

monitor appointments to the Commission, attend and participate in the public hearings and be prepared to vote on proposals on the 2018 ballot. For more information on the **Florida Constitution Revision Commission**, visit revisefl.com.
