Co-President Notes **Gail Formanack**

I have enjoyed the ease of vote-by-mail for at least 10 years. This method of voting has gained a lot of attention this election year, and I now realize I have been fortunate to reside in two states which allow “no excuse” mail-in voting because not all states make it easy. My mail-in ballot arrived in July, but I decided to relinquish it at the polls so I could have my first-ever in-person voting experience in Florida. I ventured out with my husband (serving as photographer) to Allamanda Recreation Center on the first day of early voting. We learned immediately that no photos are allowed in the room where the election takes place. Election workers wore masks, and those workers checking in the voters were behind a plexiglass barrier. I was handed a long cotton swab with which I would sign my name on the electronic pad for the signature match. I was asked to produce my driver’s license for ID, and they handled it with a clothes pin. I explained I wanted to know what the alternative IDs were, and the worker referred me to a list posted under the signature pad. Those without driver’s licenses can use a wide variety of methods to verify their ID and signature including a military ID, public assistance ID, passport, neighborhood association ID, and credit card. After confirming my identity and taking my cancelled mail-in ballot, I was given a printed form with my information and a ballot printed with my races. I was handed a new pen with which to mark it and told I could keep the pen. After marking my ballot in the booth, I put it in the privacy sleeve and proceeded to the machine when I fed the ballot in myself. There were more poll workers in the room than actual voters, and most did a good job of staying socially distant. An “I Voted Early” sticker was offered to me.

I don’t foresee giving up the convenience of mail-in voting, but I am

glad to have the chance to see the enhanced safety protocols in place at the polls. Our League will continue to promote the safety of mail-in voting. However, for those who distrust the reliability of the postal system, the early voting option seemed to be a good alternative.

Several have subgroups, for example, Election Reforms contains 3 : Write -in candidates reform, support of the National Vote Compact, and support for open primaries in Florida. 

LEAGUE OBSERVERS

As you may know, Covid 19 not only created havoc with our health- but with Florida's economy. A recent article published by WFSU- The News Service of Florida on Aug. 16th, states that revenue is estimated to be down by about \$ 5 billion over the next 2 years. Sales taxes and corporate taxes, are two of the sources which comprise our "general revenue" - and it plays a vital role in the funding for schools, healthcare, & prisons.

There is speculation the Legislature may reconvene to reconsider

the budget, however our Governor does not think this will happen. There is optimism that Florida's economic situation will improve. The Federal Government has already sent \$ 8.238 billion thru the CARES Act, and Governor DeSantis is expecting to receive additional Federal funds. One may expect the spending during the next legislative session in 2021 will be very different from 2020 as a result of Covid 19.

We will be watching and advocating for our priorities, with adjustments for the economic losses.

"Mail-in Ballots"

LWVFL is continuing to monitor the US Postal Service situation. They recognize the increase in mail-in ballots may overwhelm the postal service. For that reason, they advise mailing your ballot two to three weeks in advance of the election to ensure it is delivered. You can track your ballot to see when it is received at the election office, and you may also wish to deliver your mail-in ballot to one of the approved drop boxes in your country . Check with your county SOE for details on your ballot




Women's Equality Day Proclamation

NATURAL RESOURCES

The Dept. of Environmental Services in Florida announced they were accepting grants applications to award funds for Coastal Management. This funding was allocated by the Legislature during the 2020 session for mitigation of climate changes. The monies will be used to plant appropriate vegetation and increase the number of mangrove trees along the affected coast lines. These methods are with the approval of several non-profit groups who had been advocating for these techniques. The LWVFL also supported this effort.

Charter Schools

As the news is filled with the challenges of reopening school this fall for in-person learning, it is a good time to focus attention on charter schools.



According to the Florida Dept. of Education website, “Charter schools are public schools of choice. They are very popular- and among the fastest growing school choice options in Florida. Charter schools are largely free to innovate, and often provide more effective programs and choice to diverse groups of students.” Since 1996, the number of charters in Florida has grown to over 650. Some are initiated by community groups while others are run by for-profit entities.

Locally, The Villages Charter School is a success story. Founded by the developer of The Villages, it was designed to attract a quality work force to The Villages by limiting attendance to those who are employed by a Villages business. It has seen success in academics and has a stellar reputation. However, not all charters have this level of success. Sadly, public education money has gone to a large number of charter schools that failed within the first five years. Diane Ravitch, an education policy analyst and former official with the U.S. Dept. of Education, heads an organization which recently published their findings on the successes and failures of charter schools. Our website, **LWVTRIFL.org**, has a **Members Only** section containing multiple pages:


- the main **Members Only** page has our membership list, minutes from our last Board meeting, an Expense Voucher, our chapter's By-Laws as well as other information
