Co-President Notes

Thank you to our members who participated in the recent annual meeting via Zoom. Following a great presentation from retired Orlando Sentinel writer Lauren Ritchie, a quorum of members approved the 2021-22 program revisions, adopted a budget, and elected new officers and directors. I am particularly delighted to welcome Mary Kay Rosinski to her new role as co-president. Mary Kay served on the board for two years and has a wealth of leadership experience which will benefit our organization as it moves forward. Every strong organization requires good leadership, and I wish to thank those in our membership who stepped forward when nominated or volunteered to serve. Our organization is growing, so the new board will undertake some strategic planning this spring following an orientation meeting. The Florida legislature is busy at work in Tallahassee. Unfortunately, they seem intent on putting roadblocks in the way of those who find it safe, easy, and convenient to vote-by-mail. The League is working hard with a coalition of other groups to modify the election changes that would prohibit anyone except immediate family members from dropping off mail-in ballots, restrict the use of drop boxes, and require a yearly request for a vote-by-mail ballot. The bills are SB 90 and HB 7041. The Supervisors of Elections are united in opposition to these election changes, and the hope is that elected officials will listen to the experts before making these unnecessary changes. As these bills move through the process, please consider reaching out to your legislator when contacted with an Action Alert.

Governor DeSantis has prioritized anti-protest legislation which largely disregards 1st Amendment protections. HB1 and SB 484 are being opposed by the League along with a group of partner organizations. Again, please be willing to contact your elected officials when these bills are called up for votes.

LWVFL will host its first virtual Lobby Day on April 8th. Several of our members are registered to attend the online sessions where we will hear more in-depth information about the legislative session. We have requested virtual appointments with all members of our local legislative delegation and hope to be granted an audience with most of our elected lawmakers.

Our League has been meeting virtually now for over one year. We look forward to our members having the needed protection from the vaccines so we can safely meet in person again. Our April and May meetings will be via Zoom, but we look forward to resuming our monthly meetings in-person at Manatee Recreation Center in The Villages starting September 27th. Our long-delayed in-person celebration of the 100th anniversary of suffrage has been rescheduled for the third time. We will meet at Rohan Recreation Center on **August 26th (Equality Day) at 2:00 pm** for a screening of the PBS documentary *The Vote*, followed by a panel discussion. This program will be in conjunction with our annual Equalitea. Mark your calendars now, and more details on reservations will follow.

To the Editor:

In our current day and age, when women fill the halls of Congress and hold leadership positions, from Speaker of the House to Vice President of the United States, it is ironic that women still do not have equal freedom.

It's been 101 years since the 19th Amendment granted women the right to vote.

It's been 98 years since the Equal Rights Amendment was first

introduced in Congress.

It's been 49 years since the ERA was passed by Congress.

And it's been one year since the ERA was ratified by the required 38 states.

But the Equal Rights Amendment still needs to be added to the Constitution.

This year, after a century in the making, the ERA is closer than ever to taking its rightful place in the supreme law of our nation. What stands in our way is an arbitrary, ambiguous and legally questionable deadline for enactment imposed on the ERA at its passage.

We need the ERA because our nation must close the book once and for all on the idea that equality of rights is a debatable issue.

Because a constitution is not only a set of legal protections: it is a proclamation of a nation's values.

As March, 2021, "Women's History Month" comes to a close, make a commitment to SUPPORT FINAL ADOPTION of the ERA AMENDMENT. What a celebration we could have in 2022!

For the first time, we will develop a Vote411 Voters' Guide in an odd-numbered-year election. The election we will focus on is the City of Ocala. The bulk of our work will be from late May to mid-July. And, all of our work will be conducted online. If you are an LWV Member who is an Ocala resident and would like to work on this project, we need you. Members who wish to register voters must take a test and pass it with a 100% score. To do so, please go to the Members Only section of our [website](#), and click on Useful Info, scroll down to Certification to Register Voters. It will step you through the process. We need members who are certified to register voters and members who would like to organize voter registration drives.

We also have a need for a member who would like to track election reform legislation. The Florida Legislature is currently in session and major election procedure changes have passed the US House and are being considered in the US Senate. If you are interested in election procedures and how they impact the voters, you can help us understand what is being proposed.

In Memory of Carolyn Johnson

I asked Joanne Coen for some words about our friend Carolyn Johnson on her passing. There is a LWV here because of these two strong women.

When Beth asked me to put together something about Carolyn, I had to take my time to recall how and under what circumstances we met. My husband Richard and I moved to The Villages in 2004 from south Florida where I had been a member of the LWV of South Palm Beach County (LWV of Palm Beach County). Knowing there was a league unit here, I was looking forward to finding out more about it. I contacted Ellen Dillon whose name was given to me by the state league office. Ellen and I met, and from Ellen I found out that the unit had pretty much become dormant. She suggested that I contact Carolyn Johnson who was part of the original group. Carolyn and I met and she explained what had happened.



First and foremost, Carolyn thoroughly subscribed to the league's principle of nonpartisanship, and it was this divergence from nonpartisanship that caused the original unit to fall apart. Some of the members of the original group had a difficult time with nonpartisanship, and Carolyn, being Carolyn, could not see how the group could continue unless the members adhered to this principle. With her years of experience in the league in Pennsylvania, Carolyn knew the pitfalls.

In looking through files from 2005, I found the original application that Carolyn completed for recognition as a Member-at-Large Unit of the LWV of Florida. We remained a MAL Unit for many years until Carolyn completed the league's application to the national league for full recognition as the LWV of The Villages/Tri-County Area. During the early years, Carolyn was president, then treasurer, then president, then treasurer and director the last few years. In the early days, we all wore many hats. While preparing the budget for the annual general meetings, Carolyn would always project a membership increase no greater than 5 and always wondered if we would continue to be around the next year. We started out with 15 members in 2006 and it gave Carolyn great pleasure to see how the League grew these last several years and how our membership expanded with greater representation from Lake County.

As a 50 year plus league member, Carolyn remembered the days of league studies, consensus meetings, state and national conventions, candidate forums, etc. With the technology available now, I think she also feared that some of these traditional league activities would lose their personal appeal.

Carolyn could be stubborn but she loved the league and what it stood for and only wanted what was best for it and the members. Holiday luncheons and celebrations will not be the same without Carolyn checking you in and then trying to reconcile the sale of raffle tickets with the cash on hand! She will be missed.

To date, \$400 in memorials has been received by our tax-deductible Education Fund in memory of Carolyn. Anyone wishing to contribute to our Education Fund in her memory can make checks out to LWVTRI Education Fund and mail to Bernadette Aley at 1106 Monterey Lane, The Villages FL 32159.
