### **Co-Presidents' Corner**

The holiday season is rapidly approaching. As we have grown, we found a need for a new venue for our annual holiday luncheon. **Please note the date is December 9<sup>th</sup> to avoid conflict with holiday travel.** Our venue is Colony Cottage Recreation Center (Hearth Room). The buffet luncheon should offer enough choices to please our members. At this meeting, we also have a fund raiser. We ask each attendee to bring a new item (unwrapped) worth approximately \$20-25. These will be displayed on a table for all to see. Tickets will be sold so you can take a chance (or chances) on winning the item of your choice. Thompson, will tell us about The Open Door which offers services to the homeless in Lake County. In the spirit of giving, the League's board has approved a gift of \$50 to the charity.

After the holiday season, our regular meeting schedule resumes. January 27<sup>th</sup> is the date of our annual program planning meeting. All members will have the opportunity to have a voice in the local issues our League will act upon. More information about our current program will be made available before the meeting.

The Florida Legislature will begin its 2020 session on January 14<sup>th</sup>. I had the opportunity to visit Tallahassee November 12—13 as a member of the Women United delegation from Lake & Sumter counties. Affiliated with the United Way, this organization assisted us by granting \$5,000 for our social media campaign to motivate young women to vote in the upcoming elections. It was interesting to hear their lobbyists from RSA Consulting discuss their observations on the upcoming session. Legislators have already met for several weeks in committee in advance of the session, however many committee meetings have been canceled and not many bills have yet been filed. Some of their lobbyists' key observations and predictions are as follows: 1) The leaders of both chambers have the power to set the agenda. If a leader doesn't prioritize a bill it's not likely to see the light of day. Over 3,000 bills were filed in 2019, but only 197 were passed. 2) The trend to merge individual bills into "train" bills is likely to continue even though this forces legislators to vote on things they don't support in order to get other key pieces of the train bill passed. 3) Although the voters approved a constitutional amendment limiting the legislature's ability to authorize new casino gambling without a vote of the citizens, the need for additional revenue is likely to prompt some type of expansion of gambling through a compact with the Seminole tribe (which isn't controlled by the state constitution. 4) There may be movement in the areas of criminal justice reform because there is increasing awareness of the unnecessary cost of housing so many prisoners for level offenses.

We had the opportunity to visit with Senator Dennis Baxley and Representative Brett Hage, and they both took an interest in our issues of early childhood education, affordable housing, and assistance with tax preparation for lower income individuals. I took the opportunity to share our League's study on Voluntary Pre-Kindergarten, and I learned the anticipated bill to reform early childhood education is still being formulated by key members of the Education Committee.

I encourage others to take the opportunity to learn more about League issues and share the League's views with legislators during the LWVFL Lobby Days scheduled for February 4-5. Please let me know if you are interested in attending as a member of our League's delegation.

## The League is Non-Partisan

With 2020 being a major election year, it's important to remember that the League's Non-Partisan principle sets us apart from most other organizations. Simply

stated: the League never supports or opposes a candidate or political party. We are admired for taking this stance, and being trusted as a non-partisan organization is vital to the work we do.

At a time when impeachment inquiries are in the news, emotions are running high, and the country is so divided, it is more important than ever that we scrupulously remain non-partisan, so please take a moment to review these guidelines.

**OPTICS MATTER!** As League members, we must be careful of the events we attend and how we live our lives. Members may campaign for candidates, but never while wearing a League button or other articles that would imply we are working on behalf of the League. The President and our Voter Services Chair cannot campaign. And all Board members should be aware of sending a message of partisan bias. Be careful about what is shared on social media. Do not place campaign signs in your windows or yard. Understand that having your photo at a political event plastered all over social media is even worse than a physical campaign sign because it will be seen by even more people.

Being non-partisan does not preclude the League from taking positions on issues after study and consensus. Our positions have been consistent over the years. However, consistency is not always the case with the political parties. Support for our positions has migrated between parties. For instance, we have worked on fair districting since 1933 no matter which party controls the legislature. Generally, the party in power does not support our position. If questions of partisanship arise because of our stance, we must clarify that our position reflects a voting issue, not a party issue.

One last item that may appear to be partisan, but is not. You may see the League attend a press conference along with a political party. We will do this as long as the party's position on an issue aligns with ours. The League has a new lobbying firm that has been around for 25 years and has built relationships with both parties. That means we have a professional firm which is opening doors that were not open before. As a result, joint press conferences are even more likely than they have been in the past. If someone suggests this means we are acting in a partisan manner, please explain that we are not supporting the party but rather both organizations support the same issue.

**Topic: Local League Program Planning**

#### **What is Program Planning? How Does it Affect Our Local League?**

What is the League's definition of "program?" In the League, "program" is the process of study and advocacy of issues and is the core component of the League's mission. Our "program" positions consist of all prior issues selected by our members at our Annual Meeting which is held in March. This is true at all levels of the League, local, state and national.

Because the League is a "grassroots" organization, prior to the January meeting, members will receive a copy of the 2019-20 program which was adopted at the 2019 Annual Meeting. You will be asked to review the program and if necessary, make recommendations for changes, additions or deletions. We urge your participation in this important aspect of League membership.

The November meeting featured Karen Kagalis, an outreach employee working for the U.S. Government on the upcoming 2020 census. She shared that Florida is part of the Atlanta region which serves seven states. She emphasized the

importance of participation as \$675 billion of federal funding is spent yearly based upon the numbers generated by the census. These dollars follow the numbers, not the need, and fund vital programs such as block grants, vocational rehabilitation, free & reduced lunch for school students, and Medicaid. The numbers are also used to help local leaders prepare shelters for people who will need shelter during a hurricane. Another key use of the numbers will be in reapportioning government representation. Florida was the only state to gain two seats in the U.S. Congress following the 2010 census.

Different from the past, the primary method of responding to the census will be online. Every residence will receive a mailing with a unique code associated with it. If response by computer is unavailable, people can call a toll-free number to request a traditional print document. If no response is received, there will be follow up by census workers who will visit personally to assist with the census.

It is important to know that the U.S. government census will never ask for a Social Security number, donations, PIN codes or passwords. If you get a mailing asking for this information, it is likely a scam. All information entered online on the census site is encrypted and access is limited to trusted government workers. Challenges include a low response rate in some areas of Sumter County, especially in areas which have predominantly rental properties and limited computer access. Sumter, Marion, and Lake counties all have Complete Count Committees who will be working to increase awareness and encourage participation. All people need to be counted including those in transitional housing, transitory housing (RVs, etc.), and the homeless.

## **Voter Registration Credentials**

Just a reminder to League members who are certified to register voters, as well as League members who would like to be certified to register voters, that as of **December 31, 2018**, the certification of all voter registrars expired. League members who do voter registration for the League will need to re-certify their credentials with the State League **ASAP**. Beginning in 2017 the LWVFL instituted a 2-year cycle whereby the list of approved voter registrars would be wiped clean, requiring members to re-certify. The two-year cycle ended on 12/31/2018.

If you are interested in doing voter registration with our League, you must study the PowerPoint which is on the LWV Florida website and take the quiz, attaining a perfect score. Once you pass with 100% you will get a notification from LWVFL that you are authorized to do voter registration. ### **LWVTRI Natural Resources**

During a statewide conference call on December 2, we reviewed seven of the 35 natural resource bills which were pertinent to the LWVFL legislative priorities. Of the 10 state Florida representatives & four state Florida senators covering our three counties -- only one Bill was filed by one Rep. Clovis Watson District 20 which covers parts of Alachua and Marion counties, Rep. Watson filed

HB 365 which qualified the improvements to include sewage treatment & seawall improvements to be part of “Property Assessed Clean Energy Program”. Judith Hushon, chair of the LWVF Natural Resources Committee, also mentioned two signatory letters the LWVFL signed and were sent to the Governor and others. One was approving the Governor’s support of several locations receiving funding for environmental improvements. The second was a request to restore full funding for the Florida Forever program. The 2020 Legislative Session starting in January will be a busy one.

#### **Amendment Four Update from Cecile Scoon, LWVF 1st Vice President**

The League is still registering voters and encouraging everyone to register to vote. If you have a returning citizen and they have completed all of their written sentence, they should register to vote. If they have any questions about the completion of their sentence, then they should research it themselves or contact FRRC for assistance. The League is providing training for attorneys and advocates to be able to assist returning citizens, and FRRC is matching up returning citizens with the trained attorneys and advocates.

In short, the League is both litigating to limit the negative impacts of SB 7066 which constricts Amendment 4, while at the same time, we are trying to educate attorneys and other volunteers about how they can help returning citizens regain their right to vote through the court system.

### **From LWVUS**

#### **We've been waiting nearly 100 years for equality**

While next year is the 100th anniversary of women's right to vote,

the passage of a constitutional amendment—known as the Equal Rights Amendment (ERA)—that enshrines equality for all regardless of sex or gender, has faced obstacles since 1923.

The possibility of its passage has been renewed by the outcome of the Virginia Legislature elections in 2019, with many legislators declaring their intent to ratify the ERA. Virginia's ratification would make it the 38th and final state needed for this constitutional amendment to become a reality.

However, unlike many other of our other constitutional amendments, the ERA had a deadline for ratification of 1979 (and then extended by Congress to 1982). But hope is not lost—this month, the U.S. House Judiciary Committee ruled 21-11 to remove the ratification deadline and now the resolution moves to the House floor for a vote.

It's been almost 100 years we have been waiting and working for this amendment, let's not wait 100 more. By passing the ERA, we can firmly and resolutely declare that we believe in equality for all.
