## YOUR VOTES ARE IN: Merger Proposal Was Adopted



Thanks to the 47 members who voted on the Board's proposal to merge LWVTRI, the 501c4 organization in which you are a member, into the LWVTRI Education Fund, a 501c3.

You unanimously voted to merge the two organizations.

The Board is filing the required paperwork with the Florida Secretary of State and the IRS. Once the merger is approved, we will notify you that we are operating under our new name: the League of Women Voters of The Villages / Tri-County Florida.

## CO-PRESIDENT COLUMN: Legislative Delegation Meetings



Legislative delegation meetings are scheduled in each Florida county prior to the beginning of the legislative session. They provide an opportunity for citizens to connect with their representatives, build a relationship and share issues and priorities prior to the beginning of the legislative session.

In even numbered years, when there are statewide elections, the legislature convenes in January. In odd numbered years, the legislative session starts in March. In 2025 the Legislature convenes March 4 so counties are holding their Legislative Delegation Meetings in December 2024 and January 2025.



## GOOD NEWS: We Have Received Two Grants!!

In November, we applied to The League of Women Voters of The US (LWVUS) for two grants. One of the grants is to help returning citizens, former felons, register to vote. In Florida, that means giving them information about who will help them determine if they have paid all of their fees, so they are eligible to register. The other grant is to work with youth to register and vote.

Just as we were creating this newsletter, we were informed that LWVUS granted us \$1,000 to do the work with former felons and LWVUS granted us \$750 to work with youth to register and vote. What an honor to be selected to receive both grants!!

As a result, we will need volunteers to address the postcards, with that information, to the returning citizens. The grant money will pay for the postcards and the postage.

We will also need volunteers to attend events where youth will be involved, to help them value and act on their right to vote.
