What a wonderful turnout to kick off our meeting calendar beginning in September. With the focus on charter schools, we are very grateful to Sumter County School Supt. Richard Shirley and members of his staff for not only walking us through the process but also explaining the finances, curriculum and personnel issues connected to charter schools. Sumter County is very fortunate to have such a dedicated team working for the benefit of the students. Unlike other counties in Florida, we do not have many charter schools in the tri-county area. The Villages Charter School is the one school most of us are familiar with, and it is unique in the state because it is an employer based school. ### From the LWVUS President

The LWVUS board is meeting this weekend in Washington. As board and staff work together making decisions intended to advance the mission of the League, we are keenly aware that our elected officials on Capitol Hill have failed in their duty to work together to create a better America. What we can see around us are shuttered offices, museums and monuments, but besides frustrated tourists, the government shutdown is impacting millions of families, including those civil servants across the country who work every day ensuring that our government runs smoothly.

The shutdown also demonstrates a breakdown in how our government should function. The League of Women Voters believes that efficient and economical government requires competent personnel, the clear assignment of responsibility, adequate financing, and coordination among the different agencies and levels of government. The inability to fund the government and keep it running fails many of these key tenets.

The League's position on the role of Congress outlines what a responsive legislative process should look like. Key to this is the ability for Congress to "make decisions that meet national needs and reconcile conflicting interests and priorities", as well as "function[ing] in an efficient manner with a minimum of conflict, wasted time and duplication of effort." The government shutdown has only illuminated the issues that have riddled Congress in recent years - the impact of huge amounts of outside special interest money in elections, including primary elections, gerrymandered districts, and an inability by Members of Congress to put what's best for the nation ahead of how an issue is perceived in their home districts.

As voters we can demand that our Representatives end this shutdown and get back to work on the issues that matter to the American people. As the members of the League of Women Voters we can redouble our efforts to ensure that government of the people, by the people and for the people truly reflects and includes the voices of all the people. We can work to eliminate and overcome barriers to registration and voting; we can use this moment to highlight the need for true reform of our redistricting process; we can work for real election reform that focuses on including as many voices as possible; and we can call for public financing of congressional elections.

Let's not waste this crisis! The American people deserve better, let's help them demand it!

For our new members it will be an opportunity to take part in the consensus process. For our experienced members this is one of the reasons we joined the League. Background information, as well as the consensus questions, will be sent to all League members prior to the meeting.

Consensus by group discussion is the technique most often used in the

League for reaching member agreement. It is a process whereby members participate in a group discussion of an issue. The consensus reached by members through group discussion is not a simple majority, nor is it unanimity; rather it is the overall sense of the group as expressed through the exchange of ideas and opinions, whether in a membership meeting or a series of membership or unit meetings.

Several League members have read **REIGN OF ERROR** by Diane Ravitch, and have recommended this book as another source of background information in preparation for the meeting.

## **Ethics Review Committee**

The Ethics Review Committee continues to educate itself on ethics issues in the Tri-County area. In furtherance of that goal, the Ethics Review Committee will meet to review the day-to-day conflicts of interest that are presented to the State Ethics Commission by Town, City, and County officials and employees who are seeking the Commission's advice. By reviewing this information, the Ethics Review Committee members will educate themselves with the most frequent conflict of interest, post employment, gift restriction, lobbyist involvement issues presented to local officials and employees. ## **Natural Resources Committee**

As you know, the League of Women Voters of Florida is part of the coalition of more than 4,000 individual volunteers and 330 conservation and civic organizations from across the state working to put the Florida Water and Land Conservation Amendment on the November 2014 ballot.

At our October General Meeting, we will be hosting Pat Grierson, Florida Water & Land Legacy Campaign, Orange County Volunteer Coordinator on this important initiative. This amendment is necessary because deep funding

cuts are seriously jeopardizing the great work Floridians have been doing for decades to protect what's best about Florida: miles of beaches, beautiful parks, crystal clear springs, endless opportunities to swim, bike and fish, and an amazing diversity of plants and animals.

The Amendment will allocate less than one percent of our state budget (starting in with \$648 million in 2015) to keeping our waters clean and to protecting our beaches, springs, wildlife habitat and other natural areas for future generations! As a reminder, **THIS IS NOT A TAX INCREASE**.

On September 26, 2013, the Florida Supreme Court approved a 2014 ballot proposal that will set aside money to conserve land and other natural resources and help restore the Everglades. The Court is required to review proposed constitutional amendments to make sure they meet legal standards such as a requirement that ballot initiatives deal with single subjects and do not have misleading summary language. The Justices, in a 10-page opinion, unanimously found that the proposal known as the "Water and Land Conservation" amendment, met the standards.

So far more than 385,000 Floridians have signed, BUT to place this important amendment on the November 2014 ballot, we need to gather a total of 683,149 valid signatures from Florida voters. We need your help to reach that goal!

League members will once again be at the Lady Lake Library on Tuesday, October 8, from 11 a.m. to 1 p.m. The deadline for collecting the signed petitions is November 30, so there is still work to be done.
