## **Co-President Notes Gail Formanack**

Bonnie Field and I attended the virtual LWVUS convention held at the end of June. The Zoom platform was used to conduct the business meeting and present various informational caucus sessions. The meeting went remarkably well considering most users are still learning this technology. LWVUS CEO Virginia Case spoke about the League's ongoing work to battle voter suppression. She said the League has filed or joined 75 cases in the past two years to challenge voter suppression laws and practices. In June 2019, the Supreme Court declined to set a standard to rein in partisan gerrymandering. LWVUS launched the People Powered Fair Maps campaign, a multimillion-dollar, nationwide campaign aimed at creating fair, transparent, people-powered redistricting processes to eliminate partisan and racial gerrymandering. It will be critical to keep an eye on this process in Florida after the results of the 2020 census are known. Our local League board members are reaching out to members to learn if they are comfortable using Zoom as a platform for our meetings until we can safely gather again at Manatee Recreation Center. As the virus continues to spread, I hope you are all staying well and plan to exercise your voice at the polls in the August primary election. Many thanks to the VOTE411 team led by Carol Van Noy and Char Griffin for their work in contacting candidates and getting the information entered.

### **Observer's Report**

The budget was finally completed on June 29th. One billion dollars of the \$93.2 billion budget was eliminated by the Governor due to the revenue losses to the State by the Covid 19 pandemic. The budget line items

comprising the reduction, mainly affected issues concerning health, social, and water issues on a local level.

Governor DeSantis retained the allocations for two of his priority issues. They were also priorities for the League. Florida Forever, (land conservation), kept \$ 100 million, and the Everglades and other water restoration issues kept \$ 625 million dollars.

## **Report on the National LWV Convention**

Outgoing President Chris Carson and Virginia Kase, CEO wrote a summation of the last two years LWVUS activities regarding the "Transformation Roadmap": The League's master plan for the future.

Our League is promoting our 30-second “Be a Voter” videos on social media platforms including Facebook and Snapchat. ## VOTER SERVICES

Starting July 15, 2020, you will be able to see the candidates who will be on your August 18, 2020 Primary Election Ballot and their responses to League questions. The 2020 Primary Election League of Women Voters online Voters’ Guide will be published on [www.Vote411.org](http://www.Vote411.org), on Wednesday, July 15. From that day forward, you can go to that website, enter your home address, and click on the green ENTER button. On the next page, click the green bar that offers a personalized ballot. You will see all of the races that will be on your Primary Election Ballot. Click on any race and two candidate profiles will appear. If the candidate responded, a photo, with contact information and that candidate’s responses to League questions will be available. If the candidate did not respond, the candidate’s name and the statement: “Candidate has not yet responded” will appear under a silhouette head shot of a person.

In the meantime, [www.Vote411.org](http://www.Vote411.org) has all of the information you need to register to vote or to update your registration.

## Open Primaries on Ballot in General Election

Among the amendments on the ballot in November will be the issue of open primaries. The Florida LWV authorized a study which found that Open Primaries provide access to the broadest slate of candidates which would increase voter participation. The following position was approved by the 2017 League Convention: ***Recommend statewide use of an Open Primary system that would allow for the broadest possible voter participation, including No Party Affiliation and Minor Party***

### **affiliated voters.**

The League will be not only educating the public on this amendment but also advocating for it. Learn more by watching this video:

Advocates say open primaries would force candidates to appeal to a wider spectrum of voters and will help solve some of the problems with polarization. 42% of registered voters are registered as NPA (no party affiliation) including many millennials. Florida has 3.6 million of these voters. Many elections are decided at the primary level because many some races are uncontested. Open primaries would allow all voters to have a voice in those contests. Please consider educating your family and friends about this important ballot issue.

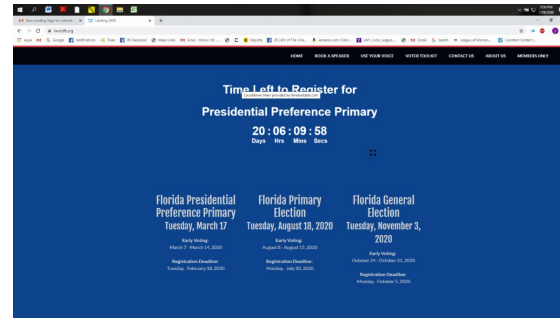
The drop down menu from the Top-Nav allows you to go directly to the page you want to access.
