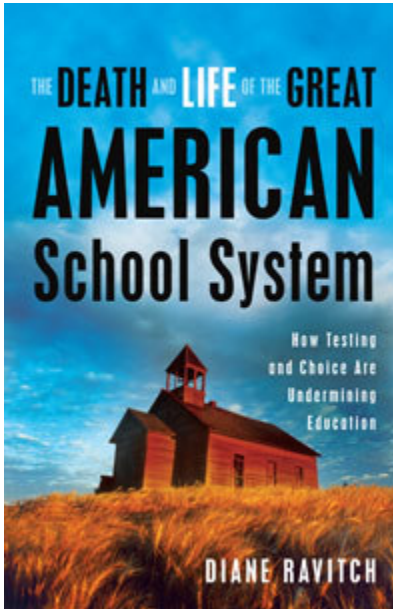

**PRESIDENT'S LETTER**

Our May 23 meeting will be the last one until September so I hope you will make it a point to attend as we kick off our participation in the LWVUS Education Study with a book report. The Education Committee has been meeting regularly to discuss the Ravitch book and there is no doubt that a lively conversation will take place at Panera's. With the end of the 2011 legislative session, there are many questions about the state of public education in Florida. Bring a friend!

For the League this has been a very disappointing session in Tallahassee. While it was expected that there were going to be cuts in education, growth management and health care, we were really taken by surprise by the draconian changes to the election law. For whatever reason, the legislators seem to be under the mistaken impression that groups like the League, Boy Scouts, church groups, college groups, etc. have perpetrated a great fraud on the voters in Florida. Of course, no one could point to anything concrete. Other changes affect amendments proposed by the legislature. The legislators, in their infinite wisdom, also saw fit to make it more difficult for voters to make changes in their registration at the polls, as well as shortening the early voting time. Across the state, supervisors of elections question the need for all these changes. They did not ask for them. This is an anti-voter piece of legislation. **At this point, all that remains is for all of us to contact Governor Rick Scott and request that he veto HB1355.** Please ask your friends and neighbors to contact the governor. ***This is not just a League issue!***

If the governor signs the Legislation, local League will discontinue registering voters in Florida. The groups registering procedure, as well as the financial penalties, are too onerous for local Leagues. Voter registration and education have been at the core of the League for 91 years. It is sad that it has to stop. Please see the press release from the state League on page 4 in this newsletter.

For those League members who will be leaving us, have a safe summer. We look forward to your return in the fall. For those League members who will be staying in the tri-county area, you are invited to join us for coffee and conversation that will begin in June. We will be studying, researching and discussing the seven amendments sponsored by the Florida Legislature that will be on the November 2012 ballot. It is never too early to start. ## VOTER SERVICE COMMITTEE

Under the auspices of this committee, the League will hold a series of **Community Conversations** beginning, **Monday, June 6, 9:30 a.m., Panera's, Spanish Springs, The Villages.**

The purpose is to research and discuss the seven proposed amendments from the Legislature that will be on the November 2012 ballot. This is in preparation for speaking engagements prior to the 2012 elections. The public will be invited to join us for a cup of coffee and conversation. Don't forget to invite a friend!

Following are the proposed amendments as well as a brief summary of each one:

**Abortion (HJR 1179)** To include in the Florida Constitution the federal ban on use of all public funds for abortion. It would also overturn all court decisions that rely on privacy rights in the Florida Constitution to reject abortion restrictions.

**Confirming justices (HJR 7111)** The Senate would confirm new justices to the Florida Supreme Court. The Legislature, by simple majority vote, could void court rules. Investigations of judicial misconduct - now confidential - would be available to the House in advance of impeachment proceedings.

**Capping state revenue (SJR 958)** Imposes a limit on state revenues based on a formula that includes changes in population and inflation.

**Veteran's property taxes (SJR 592)** Expands discount on property taxes to all veterans disabled as a result of combat, not just those who are Florida residents.

**Property taxes (HJR 381)** Gives a series of property tax breaks to first-time homebuyers, commercial property and those with second homes in Florida. First-time homebuyers would receive a homestead exemption worth up to \$200,000 to be phased out over five years. It lowers the cap on the amount a property assessor can raise the assessed value of a commercial property and non-homestead second homes from 10 percent to 5 percent each year.

**Health insurance mandates (SJR 2)** No law can "compel, directly or indirectly," anyone to carry health insurance, setting up a legal feud

between Florida and the federal government over requirements of the federal health care law championed by President Barack Obama.

**Religious funding (SJR 1218)** Repeals current prohibition of state funding, directly or indirectly, for religious institutions. This provision has prevented school voucher opponents from enacting law to provide state vouchers directly to private schools.

At both sites, you will be able to access the Legislative Staff Analysis which gives you the history and background information as well as amendments for each of these amendments.

**PRESS RELEASE FROM LWV FLORIDA  
MAY 8, 2011**

It is with great regret that the League of Women Voters of Florida announces that if the newly passed state election law goes into effect (HB 1355), the Florida League will immediately cease our voter registration efforts in this state. The League calls upon the Governor to VETO this Elections Bill, and for the Department of Justice to carefully review the impact this law will have on voting rights in Florida.

Despite the fact that the League of Women Voters is one of the nation's most respected civic organizations, with a 91-year history of registering and educating voters, we will be unable to comply with the egregious provisions contained in HB 1355.

Not only does the bill make it more difficult for voters to participate in our democracy via a decrease in early voting and new policies regarding address changes at the polls, it also imposes an undue burden on groups such as ours that work to register voters.

Under the false pretext of reducing "fraud," Florida's legislative leaders have instituted a law that will shut down the efforts of groups such as the League, the Boy Scouts, student groups, civic organizations and others who undergo the important task of helping citizens get registered to vote.

While the League remains committed to empowering an active and informed citizenry, we cannot and will not place our thousands of volunteers at risk, subjecting them to a process in which one late form could result in their facing financial and civil penalties.

By passing HB 1355, the legislature has declared war on voters. Effective immediately, the League will begin to explore legal remedies. In the meantime, the League urges Governor Rick Scott to stand up for democracy and veto HB 1355.
