This is not the first of its kind program in Florida. Civility Agreements already exist in Mascotte, Ocoee, Orlando City Council, Winter Park, Deltona and Dunedin, Florida. ## November General Meeting

As we wrap up our study on the role of the Federal Government in education, we will be discussing the final section of that study: Common Core Studies and Assessments.

The Common Core Standards provide a consistent, clear understanding of what students are expected to learn, so teachers and parents know what they need to do to help them. The standards are designed to be robust and relevant to the real world, reflecting the knowledge and skills that our young people need for success in college and careers. The initiative is sponsored by the National Governors Association (NGA) and the Council of Chief State School Officers (CCSSO). As such, the initiative is a national one and neither developed nor funded by the federal government.

**Bernice Cozewith** and members of the committee have been working on this section, and summaries of this white paper plus the questions to be discussed at the meeting will be forwarded to you. Review the material prior to the meeting and be prepared to engage in a lively discussion.

## LWVUS Privatization Study

Here is your second chance to participate in another study committee. Remember, League positions are derived at from the bottom up not the other way round like some other organizations. As you know, at the 2010 LWVUS Convention, delegates voted to study the issue of privatizing functions and services normally attributed to governments. Here in Florida, during the last session, we saw the Florida Legislature approve the privatization of a number of prisons in south Florida. The Police Benevolent Association sued the state and just recently, a Leon County judge ruled the plan unconstitutional. Gov. Scott said he would not appeal the decision; however, the Florida Legislature did not agree and they are appealing the decision. This is not an issue that will go away especially in light of budget constraints on state and local governments.

A committee formation meeting will be held on **Tuesday, November 15, 2 p.m. at Steeplechase Residences, CR103, (just off 466 by Wal-Mart) in Oxford.** At that time, we will review the material available from LWVUS and decided what areas to cover. ## From LWVUS

### Clean Air Defense

This month League President Elisabeth MacNamara asked Senators to protect America's children and families from dangerous air pollution. The League and coalition partners sent a letter to Senators urging them to oppose the Congressional Review Act resolution, sponsored by Senator Rand Paul, which would void the life-saving Cross-State Air Pollution Rule (CSAPR). In addition, the League and its partners sent a letter to the House of Representatives urging members to oppose the suite of bills contained in Majority Leader Cantor's legislative agenda, including H.R. 2681 and H.R. 2250. The League also asked supporters to take action and tell their Representatives to protect public health by voting against these bills. In appreciation, the League and coalition partners sent a letter of thanks to members of the House of Representatives, who voted to oppose the TRAIN Act, which could block two long overdue standards that would reduce pollution and protect public health.

### Tag Program

The "Be Ready to Vote" Tag program is a national first! Through the League's partnership with Microsoft, the state of Florida will be a test market for facilitating citizens' access to voting information via their smartphone. The purpose of the Tag program is to connect voters directly with their local Supervisor of Elections. The goal is to reach out to youth voters (under 30) as well as minority voters and the general public.

This is a print campaign! The universal Tag that connects users to their Supervisor of Elections can be photographed off a television or PC screen. Think of newspapers, posters, and/or flyers; all these items can be easily scanned. The directions on how to use this program come directly when the app is downloaded.
