The Presidential Primary is now over, and next up on the election calendar is **the Florida Primary, August 14** (book closing is July 16) and the **General Election, November 6** (book closing is October 9).

If you, or someone you know, want to check their voter registration status, the League of Women Voters has made it easier for you to do so. Just go to <http://bereadytovote.org/> and you can instantly find out your status. If you have a smartphone, you can scan the Be Ready to Vote Tag shown here:



Because local Leagues across the state are under a self-imposed moratorium with regard to registering voters, this is a fast and easy way to make sure your information is up-to-date. If you need to make a change, you will then be connected you to your local Supervisor of Elections via phone, email or website link to register, change party affiliation, address, name, signature or renew your absentee ballot request.

## From LWVUS

### Citizens United Decision Two Years Later

The U.S. Supreme Court issues many opinions each year and it is safe to say they all greatly impact the lives of Americans in some way. The Supreme Court's opinion two years ago in *Citizens United v. FEC* is by all accounts one that has dramatically changed the landscape of modern political campaigns in America.

Looking back, the League's commentary on the decision accurately predicted the impact we are now seeing in the 2012 elections – the birth of SuperPACs:

"The Supreme Court has made a tragic mistake. Their decision announced today in *Citizens United v. FEC* is constitutionally irresponsible and will surely bring about an anti-democratic revolution in how we finance elections in this country. Today, basic pillars of democracy have been undermined—that

elections should not be corrupted by vast corporate wealth and that the voters should be at the center of our democratic system." (LWVUS, 1/21/10)

SuperPACs are popping up everywhere. In 2010, we caught a glimpse of what was to come in American politics under *Citizens United*. Now as we sit back and watch the 2012 campaign season begin to unfold, we see that the very integrity of our elections is at stake. And the federal agency that is responsible for regulating money in American politics – the Federal Election Commission (FEC) – is totally dysfunctional. Of the six commissioners at the agency, three of them simply refuse to enforce the law, and five of the six are serving despite the fact that their terms expired some time ago.

Business as usual is not working. It is time to clean house and President Obama is the one that needs to do something about it.

How can you fight back against the big money pouring into the political campaigns this year? **Sign the petition** on The White House website\* <http://www.lwv.org/content/step-step-instructions-signing-white-house-petition>, urging President Obama to appoint new FEC commissioners. We need at least 25,000 signatures of support by February 10, 2012 in order to get a response from The White House.

## **Elections: Voting Rights Act Under Attack**

A challenge to Section 5 of the Voting Rights Act has been on the radar of voting rights groups across the country as numerous new voter suppression laws are being implemented. Section 5 requires all or parts of 16 states (called "covered jurisdictions") to "pre-clear" proposed changes in voting or election procedures with either the U.S. Department of Justice or the U.S. District Court in the District of Columbia. Last Friday the U.S. District Court in DC heard arguments to overturn Section 5. We

anticipate that this argument could be heard by the US Supreme Court before the November elections and could jeopardize a key provision that has been used to protect millions of voters. ## **From LWV of Florida**

### **LWV of Florida Responds to January 31, 2012 Federal Redistricting Ruling**

Today's federal court ruling against U.S. Reps. Mario Diaz-Balart (R-Miami) and Corrine Brown (D-Jacksonville) upheld Florida's new constitutional redistricting standards, which were passed in 2010 as Amendment 6 by 63 percent of voters.

"Today's decision further underscores the League's long-held assertion that Amendment 6 is clearly constitutional," League president Deirdre Macnab said. "This decision should send a clear message to Florida's elected leaders to stop spending taxpayer money on litigation that fights the will of the people."

***"...The question that we ask ourselves, not out loud, but we ask it just the same is this: Why is that those of us who enjoy the League of Women Voters so much, believe in it so deeply, and have found it the key to real participation in the mainstream of American political life--why is it that we cannot communicate this same feeling more widely—more widely even within the League itself?
