**LWVF Transportation Study**  
**Consensus Questions**

Every member of the League of Women Voters Florida has studied, and is experiencing daily, the impact of transportation planning in Florida. Chances are if you do not have access to a car, you have difficulty getting to doctors, stores or friends' homes.

Our dependence on automobiles and the planning that is done to accommodate our love affair with them leads to environmental disasters, health problems from exhaust/lack of exercise, and personal issues-inability to get to stores, doctors, and friends.

Below are the consensus questions for the study, and it is very important that all League members respond. Please take the time to review the questions, and send your responses to **Charlene Walker**, [cawalker7@comcast.net](mailto:cawalker7@comcast.net), no later than **April 23, 2012**.

1. When a transportation project involves more than one local League's region, how should the decision be made to support, oppose or remain neutral be determined?
  - a) All impacted Leagues should be involved in a concurrence process
  - b) Local League receiving the most impact should decide?
  - c) Local League receiving the most impact should have the greatest influence on the decision?
  
2. Funding, always a major problem, has become a major stumbling block even for road building. Most planning agencies allocate a small percentage of funds for public transit, sidewalks and bikeways and the lion's share for roads. To date, planners and

politicians include public transportation in their plans, but leave them out of funding. What percentage (emphasis) would you dedicate to public transportation?

- a) 50/50 split with roads
- b) 25/75 public transit/roads
- c) Other?

3. Funding sources are well defined – federal, state and local gas taxes plus any special taxes agreed to by voters. How can the League pressure planning agencies and elected officials at all levels to allocate more funds for public transportation? Circle all that apply.

4. LWV Tallahassee reported on their W. Tennessee Transit Project, a component of Moving Tallahassee: Cars Optional, which in turn is under the umbrella of the Mobility District plan. The District goal is to “create a safe and desirable environment for pedestrians, cyclists and transit users.”

This microcosm of comprehensive, multimodal transportation system appears to include all the goals of the LWVF’s transportation position.

Buses in those three counties do not cross county lines. Sumter County, the least populated of the three counties, has a small bus system which somewhat divides the county. The northern end of the county is serviced by the Wildwood Circulator which according to the schedule is not in service every day. The southern half of the county is serviced by the Orange shuttle. Within The Villages itself (which spans the three counties), there is a shuttle which divides the schedule between the north and south of The Villages and operates on alternating days.

#### **Rules of the Meeting**

1. Twenty percent (20%) of the membership shall constitute a quorum at the Annual Meeting.
2. Only members of the League of Women Voters of The Villages/Tri-County Area MAL Unit shall have the privilege of the floor and vote.
3. A majority of the voting members present shall be required for the adoption of the proposed program.

4. In the event of prolonged discussion of any item of business, each member will be limited to two minutes to speak to the issue unless otherwise stipulated.
5. Nominations may be made from the floor by any voting member, provided the consent of the nominee shall have been secured.

## **Minutes of the Fifth Annual Meeting**

**April 4, 2011**

The Annual Meeting was held at Taverna Red Restaurant, Summerfield, FL. The meeting was called to order at 11:00 by President Joanne Coen. There were 18 voting members present including board members: Betsy Brody, Judie Brown, Joanne Coen, Richard Coen, Steven Cooper, Janet Duncan, Helen Gozdanovic, Carolyn Johnson, and Frances Spedding.

Coen thanked members for coming and introduced the two guests and two speakers. Coen announced we had a quorum.

Spedding moved the 2010 Annual Meeting minutes be accepted as corrected, the motion, seconded by Duncan carried.

Johnson presented the financial report (attached). She also presented the proposed Budget for 2011/12 (attached). Duncan moved we adopt the Budget; the motion, seconded by Brody carried. Johnson moved that the LWV/Tri adopt \$10 as Local Dues to be paid directly to LWVTRI at the same time as a member pays annual dues to the LWVFL. The motion, seconded by Diane Jacobson, carried.

Richard Coen presented the proposed Program for 2011/12 which includes:

1. Continue to follow actions of county and local governments for the tri-county area; and when appropriate take action based on LWV positions.
2. Continue to research school governance and funding for the tri-county school districts; and when appropriate take action based on LWV positions.
3. Participate in transportation studies; and when appropriate take action based on LWV positions.

The Program is basically the same as last year. Brody moved we adopt the proposed program. The motion, seconded by Beverly Epstein, carried.

Luth Tenorio presented the slate of officers for 2011/12. They are President: Joanne M. Coen; 1<sup>st</sup> V.P.: Richard Coen; Treasurer: Carolyn Johnson; Directors: Betsy Brody, Steve Cooper, and Frances Spedding. The secretary cast the vote for unanimous acceptance.

J. Coen thanked current and outgoing board members and reviewed the past years meetings and accomplishments.

J. Coen and Charlene Walker recently attended Legislative Seminar and Convention in Tallahassee. Coen gave a summary of the events and activities at Seminar and Convention.

J. Coen again introduced the guest speakers, Nancy Noonan and Ray Seeman from Marions United for Public Education. They discussed the status of education in Marion County and Florida in general, and the impact of proposed legislation on education.

The talk began prior to lunch and was concluded after lunch, followed by questions. The meeting was adjourned at 1:30.
