## REVIEW OF LWVTRI ACTIVITIES

We spent much of our 2011 summer reading and studying for the LWVUS Education consensus. The opening meeting in **September** was devoted to Consensus on the first half of the study, Funding and Equity. **Janet Duncan, Lucy Espey-Frances, Carolyn Moores, Carolyn Johnson, Joanne Coen, Beth Hicks and Steven Cooper** presented the material. **Charlene Walker** was our recorder. **Carolyn Johnson** led the discussion.

In **October**, **Nancy Velez, Chief Academic Officer, Lake County School District**, spoke to about the inclusion of civics in the curriculum as well as an educator's perspective on Common Core Standards.

The second half of the Education Study Common Core Standards, was the topic for our **November** meeting. **Bernice Cozewith** served as moderator and **Charlene Walker** was recorder. **Betsy Brody, Judie Brown** and **Al** and **Pat Wichman** made presentations.

Our LWV advisor, **Caroline Emmons-Schramm**, was our guest in **January** and we discussed possible program items and directions for the coming year. Our program selections reflect what we discussed at this meeting.

**Former Governor Buddy McKay** spoke to us in **February**. This was a special meeting and we anticipated a larger group would attend. Happily we were correct and the Lady Lake Community Building proved to be an excellent meeting place. Gov. McKay was a very interesting and knowledgeable speaker.

Although it was hard to follow Gov. McKay, **Dr. Charles Mojock, LSCC President**, did a pretty good job at our **March** meeting. Meeting at the Leesburg Library for the first time, Dr. Mojock gave an interesting presentation giving us information about the place of community colleges in education. Additionally, LWVTRI, along with other organizations, cosponsored a Celebration of Women's History Month at Lake-Sumter Community College.

# **Florida College Students Can Use Their Smartphone to Ensure Their Vote Counts This Year**

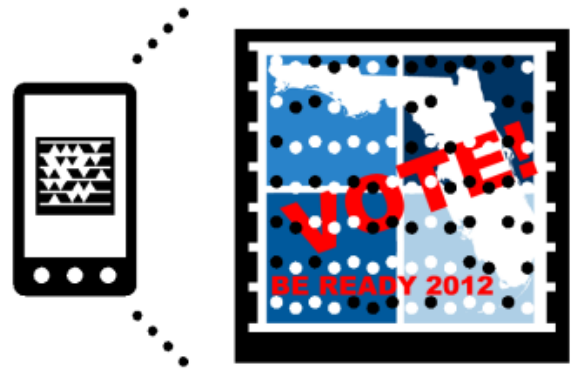

Before you leave campus for the summer, be prepared for the fall.

The nonpartisan League of Women Voters of Florida has made it simple to make sure your vote counts this important election year. Using the League's "Be Ready to Vote" Microsoft Tag, one scan with your smartphone

does it all. Scanning the Tag with your smartphone lets you contact the Supervisor of Elections' office for your county, no matter where you live in Florida, to check and update your voter registration status. Voters can also visit

## **WHAT YOU NEED TO KNOW**

Florida will have two important elections this year: the Primary Election on August 14 and the General Election on November 6.

Florida voters must be registered 30 days in advance of each election. Election laws in Florida have recently changed. You should check your voter registration status now.

Have you moved recently?  
Has your name changed?

Voters could be penalized if their name has changed or they have moved without notifying their Supervisor of Elections' office about the change.

Don't take a chance that you could be handed a provisional ballot on Election Day. Make absolutely sure your vote will count. Scan the "Be Ready to Vote" Tag or visit [www.BeReadyToVote.org](http://www.BeReadyToVote.org) to be connected.
