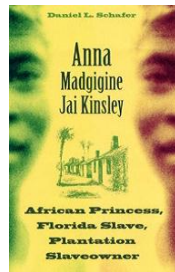
## **Membership**

## News from LWVF

League members from Florida will have an opportunity to lobby on behalf of the League at the Legislative Summit and 2013 Convention which will be held in Tallahassee beginning Wednesday, April 10, 2013 and ending on Saturday, April 13. The Legislative Summit begins with the Old Capitol Gala on Wednesday evening, and continues the next day with legislative briefings from elected officials in the morning and lobbying representatives and senators in the afternoon. Friday is the start of the LWVF Biennial Convention with the wrap-up on Saturday afternoon. This is a great opportunity to meet with legislators and network with other league members. Deirdre Macnab, president of the League of Women Voters of Florida, has been named Central Floridian of the Year 2012 by the "Orlando Sentinel."

Citing Macnab's dynamic approach to leadership, the Sentinel said, "Florida's League of Women Voters, founded in 1939, has been on a roll since Macnab took charge in 2009. It spearheaded the coalition that persuaded voters in 2010 to reform the state's hyperpoliticized and often profoundly unfair process for drawing legislative and congressional districts.

"The League and its allies convinced a federal judge to strike down part of a 2011 state law that severely restricted voter-registration drives.

"And the group fought alongside others for extra early-voting hours last year. Gov. Rick Scott rejected their request but now apparently has seen the light."

League of Women Voters of Florida, issued this statement in response to the Governor's release of recommendations for election reform:

*The League of Women Voters of Florida applauds Governor Scott's recent recommendations for election reform. From increasing the number of days for early voting from 8 to 14, allowing local Supervisors of Elections more flexibility in determining early voting locations, and restoring shorter ballot language for voters, these steps are essential to helping us put Florida's elections fiascoes behind us once and for all. It is imperative to not only restore citizens' confidence in our electoral process, but also to show America that Florida can be synonymous with excellence in elections. We applaud the Governor for taking a critical first step, and we now look to the Florida Legislature to do their part to protect our state's democracy.*

## **News from LWVUS**

### **Voter Registration Modernization in the Spotlight**

The Brennan Center for Justice held a panel discussion on voter registration modernization this week in DC. with Secretaries of State from MN, ND, NV and OR who discussed the need for on-line voter registration modernization. In conjunction with the panel discussion the Brennan Center also released a new publication - The Case for Voter Registration Modernization. Registration modernization is one of the four pro-voter reform issues the League has identified as priorities this year at the state and federal level.

### **Women and the Rule of Law: A View from the Americas**

A one-day conference, jointly sponsored by the League of Women Voters, Inter-American Dialogue, and International Association of Women Judges, will take place in Washington DC, on February 27, 2013. The conference will showcase the progress that women have made in gaining access to judicial leadership positions across the Americas. A central purpose will be to draw on the collective experience of accomplished judges to develop recommendations on how to enhance the positive role of women in the judiciary.
