## February General Meeting

The subject was Human Trafficking and the importance of the subject was such that we had one of our largest turnouts for a General Meeting.



**Lake County Sheriff Gary Borders** and members of his Office, along with a representative from DCF, made a presentation on Human Trafficking in Central Florida and Lake County in particular.

**Detectives Danny Morales** and **Amber Warren** from the Sheriff's Office discussed Human Trafficking and Labor Trafficking with our members and invited guests and then answered questions from the audience. Additional information was provided by **Joelle Aboytes** from the **Florida Department of Children and Families**.

At the end of the presentation, our members and invited guests were told that further public awareness of the severity of this problem would go a long way towards making it more difficult for criminals to operate in this area. Additional funding is needed to both prevent these crimes and allow for assistance to be provided to the victims of Human Trafficking. Lake County members will follow-up on Sheriff Borders' request that they contact

their elected officials to ask that his Office and DCF be provided with the assistance and funding to allow them to better deal with the problems associated with Human Trafficking. The League is pleased to announce that our members have been invited to participate in the Resident Academy which is sponsored by The Villages Community Development District. The dates and times are **April 20 & 21, 8:30 a.m. - 1:00 p.m.**



This learning opportunity was presented to us by **Janet Tutt, District Manager** of The Villages, who saw Carolyn's piece in our February newsletter outlining what the Local Government Committee would be working on.

The Resident Academy is an interactive program open to Villages residents who are interested in learning about their local government. The ultimate goal for the Resident Academy is to alleviate the confusion, questions, or misinformation that exists throughout the community regarding the responsibilities and functions of the Community Development Districts. During this program, participants will receive an in-depth look at the various District Departments and how they work together. Department Directors will also be available to answer questions or make appointments for those seeking additional information.

For those League members who don't live in The Villages, this is an excellent chance to go behind the scenes and educate yourself on the operations of a Community Development District which are covered in Florida Statutes. ## Natural Resources

**Annie Grewe** and **Kathy Hansen**, along with a group totaling 35 people, boarded a bus in Ocala for the 3-hour ride to Tallahassee. They represented many different groups, including the League of Women Voters, Sierra Club, Preserve Our Environment, Ideas, Save Our Springs and others. In joining the Rally of several hundred people waving banners in front of the steps of the Old Capitol Building, they were aware that they were representing thousands of people who could not be there. They were there to let legislators know that Amendment 1 was passed by 75% of Florida voters and that they were watching to make sure that the revenue from the documentary tax will be allocated to protect our waters at the sources, as was intended.



Many people carried signs protesting dangers to the environment including hydraulic fracturing. Others encouraged positive actions. Leaders representing the coalition of groups spoke to us-**Chuck O'Neal (LWVF)**, **Bob Knight (Dir. Of the Florida Springs Institute)**, **Katie Tripp (Save the Manatee Club)**, **Gary Appleton (Sea Turtle Conservancy)**, former Attorney General **Bill McCollum**, and many others. A common theme was that the first priority should be to acquire the lands necessary to protect Florida's drinking water sources from inappropriate development and pollution.

After Anne & Kathy left the rally, they went to the office of **Rep. Marlene O'Toole**. She was not available to see them; but they spoke at length with her legislative assistant and expressed their concerns. Next, they found the office of **Sen. Hays** in the Senate Office Building and spoke to his assistant. When they learned that Sen. Hays was in the meeting of the Environmental Preservation and Conservation Committee on the lower level of the Building, they followed him there.

Committee members were working on the first step of handling Amendment 1 money, which is to create a trust fund within the Department of

Environmental Protection. **Committee Chair Sen. Charles Dean** stated that all current programs are being rolled in to the Trust; none are being eliminated. It was an interesting day experiencing being part of the Democratic process.
