Adopted 2015-2016 LWVTRI Program

Local Government-promote an open government that is responsive to the people of the tri-county area.

- Monitor Fruitland Park districting.
- Monitor privatization and outsourcing efforts in county governments.
- Research county and local Master Plan permitting on water usage.
- Support transparency in local government.

Voter Service-continue to provide information about elections, election process, redistricting, amendments, and changes in the election law regarding voter access.

- **Monitor** LWVF position to automatically restore voting rights for former felony offenders.
- Promote the Speaker's Bureau.
- Facilitate awareness of voter registration in high schools.
- Promote voting **especially** among 18-30 year olds.

Education-continue to focus on universal access to public schools with support for equality in academic requirements and funding.

- Keep informed about the local impact of Federal and State initiatives such as Race to the Top, No Child Left Behind, Common Core standards and FCAT especially those topics studied in the recent LWVUS Education Study.
- Monitor impact of charter schools and vouchers on public schools.
- Research the impact of state funding on local school districts.
- Research administration of Pre-K programs.

Justice in Florida-support juvenile justice actions that emphasize civil citations, rehabilitation, and other alternatives to incarceration.

Natural Resources-promote an environment beneficial to life through the protection and wise management of natural resources in the public interest by recognizing the interrelationship of air quality, energy, land use, waste management and water resources.

- Study structures and powers of Florida Water Management Districts.
- **Investigate school programs on recycling and sustainability.**
- Monitor legislation regarding hydraulic fracturing

Issue for Action: Monitor the implementation of Amendment 1.

Social Policy-secure equal rights and equal opportunity for all. Promote social and economic justice and the health and safety of all citizens.

- Support the LWV Florida's position of accepting federal funding for the expansion of Medicaid eligibility.

Issue for Action: Support the safe rescue and rehabilitation of victims of human trafficking and the education of the public about this issue.

Education

As mentioned last month, education issues are a priority for the League and one excellent resource to help you keep up-to-date, not only here at home but across the country, is the LWV Education Blog which is coordinated by Sue Legg, a member of the LWV of Alachua County.



We have been following HB7037, one of four education proposals that have been approved by the House. This bill would create the Florida Institute for Charter School Innovation, make it easier for top-performing charters to replicate themselves in high-need areas, and specify

in the *Tampa Bay Times*, "The bill that passed Friday (March 27) would ensure charter schools receive about 40 per cent of the amount traditional public schools can raise for construction and maintenance.... If the state does not provide enough money in the budget as it has done in recent years, the school districts would have to make up the difference with their tax revenue." This is just one issue relative to education that the League is following.

The Education Team blog is a forum to promote the exchange of information on school reform. They do fact-based studies, and encourage posts with reference citations that contribute to a better understanding of different points of view about school choice issues. Natural Resources

The Committee has been active in voicing their concern about the funding of Amendment 1. League members have contacted Sen. Hays' office and registered their disappointment with the under funding. As reported in the most recent *Capitol Report*, "...the Senate boosted funding for land acquisition from \$2 million to \$37 million on Wednesday (April 1). This is at least a positive step in the right direction in order to fulfill the Constitutional obligation that was voted for overwhelmingly by the people of Florida. Ongoing advocacy by members across the state will be important to support the work we are doing up here continuing to keep the pressure on to fund the purchase for land acquisition." Thank you to the Preserve our Environment Club and The Villages Environment Club for enlisting their members in this effort.
