### President's Pen

The League of Women Voters has always had *the right to vote* as a core value. These days we need to be very aware of ways that this basic right is under attack.

1. **The President's Advisory Commission on Election Integrity** needs your attention. This commission is chaired by Vice President Mike Pence with Kansas Secretary of State Kris Kobach as vice chair. Their mission "is to root out voter fraud." A side "benefit" for many seems to be denying the right to vote by using challenges and activities that make it difficult if not impossible for some to vote. Please keep up on this body and their activities!
2. **Restoration of Rights for Former Felons in Florida.** There are over 1 MILLION Floridians who have permanently lost the right to vote due to a felony conviction. Some of these non violent felons never went to prison, but served in diversionary programs. Does not matter. The process in Florida for restoration of rights costs an average \$8000 and takes years. The LEAGUE is involved in gathering signed petitions for a constitutional amendment to restore rights for non violent felons at the conclusion of their sentence. Please take the time to sign a petition and perhaps get friends to sign them. Our next meeting, October 23 will have a program on this topic and petitions will be available.

There is so much going on. Find where you can fit in and join us.

**Topic: Restoration of Voting Rights Amendment  
Presenters: Beth Hicks & Carol Van Noy**

In order to get the Voting Restoration Amendment onto the 2018 ballot, 700,000 petitions from Florida voters need to be collected by December, 2017.

The proposed ballot summary is as follows:

This amendment restores the voting rights of Floridians with felony convictions after they complete all terms of their sentence including parole or probation.

The amendment would not apply to those convicted of murder or sexual offenses, who would continue to be permanently barred from voting unless the Governor and Cabinet vote to restore their voting rights on a case by case basis.
