A: While the Lake County Water Authority does not control permitting or other codes, they do have a role in assisting and partnering with local governments. I believe that working together in lobbying the state for funds, applying for grants, and coordinating action plans based on runoff pollutants is essential to getting the most for our taxpayers at the county and local level. Constant communication and collaboration concerning nutrient and water levels is key to getting the best results for our lakes and all of us who depend on them.

A: I believe a two-pronged approach is necessary. First, water conditions have already become degraded over many years, and continued remediation will help to clean up the water. Remediation can occur using a variety of methods, such as the existing NuRF operation and some city water treatment projects. Second, the Water Authority should work to prevent further issues. When dealing with environmental issues, prevention is often far more cost-effective than cleanup after allowing problems to occur. Stormwater

treatment projects, as well as education of citizens to help them make informed decisions, can help keep pollutants out of our water. Whatever actions taken should be carefully considered in order to best utilize resources and most efficiently accomplish goals.

Q: *What ideas do you have to assist local governments dealing with storm water runoff?*

A: In addition to maintenance and evaluation and improvement of existing stormwater projects, I am interested in exploring the use of green space, new paving technologies, and other methods for reducing runoff and improving infiltration of water instead. I am also interested in the use of plants to take up excess nutrients, particularly because this can result in both water quality improvements and also community enjoyment of public areas. If water cleanup can be paired with community beautification or recreation, it increases value for citizens.






