

### Voter Registration Credentials

Just a reminder to League members who are certified to register voters, as well as League members who would like to be certified to register voters, please note that as of **December 31, 2018**, the certification of all voter registrars expired. League members who do voter registration for the League will need to re-certify their credentials with the State League **ASAP**. Beginning in 2017 the LWVFL instituted a 2-year cycle whereby the list of approved voter registrars would be wiped clean, requiring members to re-certify. The two-year cycle ended on 12/31/2018.

If you are planning to do any voter registration you must study the PowerPoint which is on the LWV Florida website and take the quiz, attaining a perfect score. Once you pass with 100% you will get a notification from LWVFL that you are authorized to do voter registration. ## **Education**

With Education being one of the top priorities of the League this legislative session, bills that are making their way through the legislature of deep concern to the League are bills pertaining to arming Florida's teachers and expanding the taxpayer-funded school vouchers. However, before we discuss the aforementioned bills, we would like to draw attention to proposed legislation that focuses on one aspect of education that our League is very interested in-- Florida's Voluntary Pre-Kindergarten Program.

**HB1193 & SB1594** revise accountability requirements for the Voluntary Pre-Kindergarten Program (VPK). While our League is supportive of this legislation, and according to **Linda Carpenter**

**LWVTRI VPK Committee Co-Chair**, "... we commend them for including teacher training and for specifying content areas, but disagree with what they are recommending as a vehicle for this training. Eight hours is a drop in the bucket, especially for all they are planning to include in instruction: 5 hours devoted to instruction in strategies and techniques to address the age-appropriate progress in developing emergent literacy skills, and 3 hours devoted to strategies and techniques to address age-appropriate progress in attaining performance standards. All training specified focuses on assessing progress rather than teaching. Online is an absurd delivery system. . .we know it doesn't work for or help most teachers in their own classrooms. And not requiring it is a huge mistake. We either want a high-quality program or we don't." As members know, we have been studying the VPK program for the last few years ([Click here to read the summary of our position and work on this issue.](#)) and our position speaks to increased funding for the program as well as "Provide funding for and offer appropriate in-service training for teachers so that VPK students receive better preparation for kindergarten and beyond. Ideally, teachers need opportunities to be coached in their own classrooms as in a Master Teacher Program developed in Polk County."

**CS/CB7030** provides exemptions under the Coach Aaron Feis Guardian Program, "individuals who exclusively perform classroom duties as classroom teachers" are currently exempt from the program. This bill would repeal that provision.

**HB7075** would raise the income level threshold to qualify for vouchers to 375% of the federal poverty level, meaning that by 2022 a family of four making \$94,125 would be eligible for tax-funded vouchers to schools not held to the same standards as public schools.

SB7070 creates Family Empowerment Scholarship (Voucher) in FEFP, Funds Best and Brightest bonuses in FEFP, allows a Hope Scholarship redo... this is the massive Senate Education train that pairs much needed school construction regulatory relief and the creation of Community School programs for struggling neighborhoods, with an ill-advised teacher bonus program (in lieu of increased funding for salaries) and a massive expansion of private school vouchers, to be funded directly from local property taxes.

**HB7095** Expands Schools of Hope (enticing out of state charter chains to establish networks in Florida) and Florida Opportunity Zones, allows funding for executive directors, regional directors, leasing... this is the massive real estate grab (at tax payer expense) that was outlined in Governor DeSantis' implementing bill. The bill would allow "Hope Operator" charter chains to open in "opportunity zones" regardless of whether the local public schools were failing... there are "Opportunity Zones" in EVERY school district in Florida, even the high performing, A+ districts., greatly expanding potential locations for these so-called Schools of Hope charter schools.
